### **Constitutional Law**

#### **GROUP - B**

#### **PROGRAMME OUTCOMES**

Students who have studied the Masters Degree Programme in Constitutional Law are expected to have:

PO2. The capacity to analyse the Constitutional text and its expanded interpretation by the Judiciary

PO4. The ability to fully appreciate the diverse approaches of the Court of law in the application of Constitutional law in general, and the nature of judicial process in particular.

PO6. The acumen to understand how Constitutional law can be applied in the courts to give effective remedies against wrongful state actions.

PO7. The ability to engage in meaningful research in law.

PSO1. Develop the power of critical legal thinking to enable a piercing analysis of laws and judicial decisions

## **FIRST SEMESTER**

### **Constitutional Law- New Challenges**

#### **COURSE OBJECTIVES**

This course is designed to give the students a deeper understanding about the Fundamental Rights under our Constitution. It has been framed to help the students appreciate the dynamics of the rights regime in India. The course also enables an understanding about the how, and to what extent, global constitutionalism impacts the interpretation and application of the law through the adjudicatory machinery. The course also focuses on the new and emerging challenges to Constitutional jurisprudence in India.

#### **COURSE OUTCOMES**

The following outcomes are expected from this course

1. Helps to comprehend the Fundamental Rights with a deeper perspective.
2. Throws light on the dynamic role played by the Judiciary.
3. Helps to grasp the transformative nature of the Constitution.
4. Helps to understand how the emerging challenges to the Constitution are met by the Indian Judiciary.

### **Constitutionalism and Pluralism**

#### **COURSE OBJECTIVES**

This course has been framed with the objective of giving an in-depth understanding about Constitutionalism and its enduring vitality. It also aims at polishing a student's understanding about how the concept of pluralism informs every aspect of constitutional jurisprudence in India. It thus seeks to help the learners to appreciate the values of constitutionalism and pluralism and more importantly, to understand how these values influence the court's power of judicial review.

#### **COURSE OUTCOMES**

Students graduating in this course will be able to:

1. Garner a deeper understanding of the Constitutional values of Pluralism & Constitutionalism.
2. Understand the in-depth analytical differentiation between different polities.
3. Get a deeper insight in the emergence of the concept of Judicial Review and related doctrines that guide the Judiciary.
4. Help the students to understand the role of Judiciary and the Legislature in the light of certain inviolable characteristics of the Constitution.

5. Understand the comprehensive electoral mechanism established under the constitution.

## **Federalism and Union-State Relations**

### **COURSE OBJECTIVES**

This course is aimed at giving an in-depth historical account of the federal structure adopted by the Constitution. Hence the course expects the students to understand how Indian federation has been unique since its inception. It is also designed to help students understand the model of federation that is adopted in India, marking a stark departure from other typical federations in the world. This course aims at providing the students with a detailed knowledge about distribution of powers and the principles involved in the interpretation of provisions defining Union-State relations. Thus this course should equip the students with a comprehensive knowledge about the unique federal structure of the Indian polity.

### **COURSE OUTCOMES**

Students who have studied this course will be able to:

1. Understand not only the traditional concept of federalism but also the transition to, emergence and adoption of co-operative federalism in the Indian Constitution.
2. Appreciate with intricate details, the power sharing between the different tiers of Government on legislative, administrative, & fiscal plane.
3. Know the role played by the judiciary as an impartial arbiter in resolving the disputes in a federal structure.
4. Understand the various modules of the Government that are aimed at fostering co-operative federalism.

## **SECOND SEMESTER**

### **National security and Rule of Law**

#### **COURSE OBJECTIVES**

This course focuses on the specific area of national security under the Constitution in order to help the students understand the rule of law foundations of national security. This course has been designed to foster an understanding of how national security concerns are addressed by the Constitution of India. It also aims at educating the students about how the scope and extent of judicial review greatly differs in the domain of security issues from that in other areas of Constitutional Law. Also the course is designed towards helping the students understand the shift in national security scholarship.

## **COURSE OUTCOMES**

Students studying this course will be able to:

1. Map the transition from classical concept of national security to the modern concept of national security.
2. Critically analyze the emergency provisions in the Constitution vis-a-vis national security.
3. Get an overview of various security legislations in India, martial Law and the International efforts to combat terrorism globally.
4. Understand how the interplay between the civil liberties and the emergency provisions is enhanced.

## **Administrative Process**

### **COURSE OBJECTIVES**

This course has been designed to provide a detailed understanding of the impact of Welfare State in India. It is believed that students should be able to have a clear understanding about how the emergence of Administrative Law is directly and robustly relatable to the adoption of an intensive form of government. Also this course aims at furnishing a detailed account of Administrative functioning and the principles and doctrines that act as conceptual barriers to the abuse of power by the State. Hence this course is extremely crucial for those working within administrative structures of the State.

### **COURSE OUTCOMES**

1. In-depth understanding of the transition from Laissez Faire to Welfare State and the emergence of Administrative Law.
2. Helps in understanding the concepts of Rule of law and Separation of Powers in the contemporary sense.
3. Throws a light on the various functions performed by the administration.
4. They get a critical insight in the Subordinate Legislation, its necessity, constitutionality, etc.
5. Throws a light on the evolved mechanism of the administration in easing the internal working.

## **THIRD SEMESTER**

### **Judicial control of Administrative Power**

#### **COURSE OBJECTIVES**

This course aims to foster a clear understanding about the institution of the judiciary and how it is instrumental in controlling administrative power. It is aimed at highlighting on the student's mind the importance of control mechanism itself. Since judicial control mechanism is the most robust one and integrally important for students taking to advanced studies in law, this course specifically aims to focus upon the different modes through which the judiciary can exercise these powers. This course also attempts to inform the students about the various limiting principles operating upon the judiciary to ensure its impartiality and fairness in the decision making process so that the judiciary is able to exercise an effective check over the ever growing powers of the administration.

### **COURSE OUTCOMES**

Students studying this course will be able to:

1. Understand the necessity of control mechanism over the administrative powers is understood in great detail.
2. Know in detail the various modes of control by the judiciary which are routinely dealt with like writs, SLP, PIL, etc.
3. Understand the extent of Judicial Review, the restraints on its exercise along with ouster provisions.
4. Exhibit a comprehensive understanding of the principles of natural Justice, as cardinal principles of limitation to induce fairness in decision making.

## **FOURTH SEMESTER**

### **Judicial Process and Rule of Law**

#### **COURSE OBJECTIVES**

This course aims at concentrating on the judicial institution in order to help students gain a refined understanding about the nature of judicial process. It aims to develop an in-depth understanding about the multi-dimensional role of the judiciary. This course will help students analyse the conceptions of judicial independence and judicial accountability. Also, this course contains a conceptual understanding of the all-important principle of Rule of Law in order to make students appreciate its enduring vitality.

#### **COURSE OUTCOMES**

Students will be able to:

1. Understand the pursuit of judiciary in protecting the fundamental rights and constitutional values.
2. Understand why independence of judiciary is of vital importance and how it is protected by various constitutional and statutory provisions.
3. Understand the intricate balance between the competing values of Independence and Accountability of Judiciary.

4. Appreciate the reasons behind judicial law-making and its criticism of being anti-majoritarian.
5. Understand the exceptional power of the Supreme Court to do complete justice as an exception to the doctrine of Precedent.

### **Public authorities and liabilities: Control on Maladministration**

#### **COURSE OBJECTIVES**

This course focuses on maladministration and looks at the other remedies outside the judiciary. Hence it aims at conditioning the minds of the students to understand how extra-judicial measures and mechanisms could deal with maladministration. The students are introduced to other modes of control on administration apart from the Judiciary. The course also aims at developing in students the ability to analyse the advantages and dis-advantages of these measures vis-a-vis judicial controls.

#### **COURSE OUTCOMES**

Students are able to:

1. Appreciate the importance of informed citizenry and an open and transparent government.
2. Understand the role played by the Internal control mechanisms like Ombudsman and CVC to control maladministration.
3. Make a comparative study of judicial control mechanisms verses the others.

## **LL.M. Degree Programme**

### **BUSINESS LAW**

#### **GROUP D**

#### **PROGRAMME SPECIFIC OUTCOME:**

PSO1: Demonstrate exhaustive understanding of variety of substantive procedural laws including various legislations and connected rules and regulations in the area business law.

PSO2: Learn the art of doing doctrinal and empirical research which covers knowledge and implementation of various tools and techniques of research.

PSO3: Develop organizational skills necessary for successful functioning of law in business practice and demonstrate advanced analysis of statutory provisions and case-law; sophisticated legal reasoning; and well-developed skills in creative thinking to generate appropriate legal and practical responses to those issues.

PSO4: Explain the key aspects of the body of legal rules that regulate companies and other popular business forms in India, and contemporary developments.

#### **PROGRAMME OUTCOME:**

PO1: To provide knowledge of Business Law to the interested learner's to train those in management and administration who wished to build career in various government departments, public and private sector.

PO2: To provide trained Human Resource to the growing corporate Sector in the State and Centre.

PO3: To provide a platform of self-employability, as learners after successful completion can start professional practice.

PO4: The objective of the program is to produce professionally trained learners to be associated with the fast growing new type of business called as "E-commerce".

PO5: To Interpret and analyze the legal and social problems and work towards finding solutions to the problems by application of laws and regulations.

PO6: To apply ethical principles and commit to legal professional ethics, responsibilities and norms of the established legal practices.

PO7: Student is equipped with the knowledge of teaching methods thereby enabling them to enter the teaching profession.

### **COURSE OBJECTIVES AND COURSE OUTCOME**

#### **Subject: 1. CORPORATE LAW - I**

#### **COURSE OBJECTIVES:**

In view of the important developments that have taken place in the corporate sector, the course is designed to understand the formation, management and other activities of the companies. Important regulations pertaining to the issue of shares and the capital raising have come into force. This course aims to impart the students, the corporate management, control, the remedies and government regulation of corporate business and winding up of companies. This course provides students with an integrated understanding of the body of legal rules that regulate companies in India. Topics covered include the management and control of companies; the process by which companies transact; and the process by which companies are both initiated and brought to an end. Detailed consideration is also given to the notion of corporate personality; the means by which companies can be financed; and the rights of creditors, shareholders and other stakeholders. The rules regulating other business structures are also considered.

#### **COURSE OUTCOME:**

CO 1	Students will be familiarized with the concept of incorporation, formation of company and basic documents required for the formation of a company such as MOA, AOA, and prospectus.
CO 2	The student will also be able to appreciate the principles, theories and models of business enterprises.
CO 3	The students are familiarized with the concept of Corporate Social responsibility and issues relating to corruption, code of ethics, and environment.
CO 4	The students will get an insight into corporate frauds, reasons and the ways and means to deal with the same.
CO 5	The students will be familiarized with the concept of share capital, kinds of and importance of its stakeholders and debenture holders.
CO 6	The students will know the role and duties of Board of Directors in corporation.
CO 7	The student will get a detailed knowledge about corporate debt financing and inter corporate loans and investment.
CO 8	The students will be able to understand the importance of the responsibilities of a corporation towards the society.



## **Subject: 2. COMPANY AND SECURITIES LAWS**

### **COURSE OBJECTIVES:**

The purpose of this course is to study the internal functioning of a company. In this course the students will be introduced to the basic management structure in a company, the law regulating appointment of directors, the directors' duties, matters governing board meetings, matters governing company meetings. The continued growth of our capital markets accelerated enormous demands and opportunities for lawyers and other skilled securities market professionals with expertise in securities laws. The course will also develop broad perspectives on Indian and international securities laws in all their dimensions. Securities Laws seeks to develop securities lawyers with an equally fine and dedicated group of students to transfer to them the skills necessary to meet those demands and take full advantage of the opportunities they present.

### **COURSE OUTCOME:**

CO 1	The students will have an understanding of Corporate Governance from a managerial as well as legal point of view.
CO 2	Understand the concept of majority rule and its exceptions, modes of winding up of company and distribution of assets in the event of winding up.
CO 3	The students will be able to understand the role of Auditors in the management of a company and also get the requisite knowledge about the audit committee.
CO 4	The students will be able to understand FDI, mutual fund and other investment schemes.
CO 5	The students will be able to understand the legal framework of civil and criminal liability and winding up of a company.

## **Subject: 3. ECONOMIC LEGISLATION**

### **COURSE OBJECTIVES:**

This course aims at an all encompassing view of the Contract Law, Sales of Goods act; Partnership act and Negotiable instrument Act and introduces the students to the different aspects of the same. This course is designed to provide the student with knowledge of Consumer protection Act, in which a consumer and businesses operates, and Provide the knowledge about constitutional aspects of consumerism. It is designed to enable them to identify the fundamental legal principles behind contractual agreements and different forms of business organizations viz., Partnership under Indian Partnership Act with the emerging trends.

**COURSE OUTCOME:**

CO 1	Know the Indian Contract Act 1872 and the essential provisions of contract as well as understand the meaning and the importance of valid and enforceable contracts and the consequences of breach of contract.
CO 2	Learn the legal aspects of Partnership act.
CO 3	Provides the working knowledge of the legal framework of consumer dispute redressal agencies, their composition role power and functions.
CO 4	Understand the concept of sale of goods act 1930 and can critically evaluate conditions and warranties of sale of goods act.
CO 5	Know About the Negotiable Instrument Act 1881 and will be able to use negotiable instrument in practical life

**Subject: 4. LEGAL REGULATION OF ECONOMIC ENTERPRISES:****COURSE OBJECTIVES:**

The course on legal regulation of Economic Enterprises primarily concentrates on making students understand the rationale behind enactment of regulations by the government to regulate the Indian Economy. The subject begins with the unit which enunciates Constitutional and Historical background which gives the authority to Government to make Economic Regulations. It goes on to cover six different Acts which are important to shape the Economic policy of the country along with few regulatory authorities which are important for the economic development of the country.

**COURSE OUTCOME:**

The students after studying this subject are able to:

CO 1	Understand the law which gives the authority to the Government from where it draws the power to legislate on economic activities.
CO 2	Appreciate the change in the economic policies that was brought about by the Government over the years since India got its Independence.
CO 3	Analyse the importance of those statutes that are important for the regulation and control of Industrial, trading, capital and financial activities within the country.
CO 4	Understand the composition, powers and functions of four major regulatory authorities within the country.

**Subject: 5. INTERNATIONAL TRADE LAW AND AGREEMENTS (I)****COURSE OBJECTIVES:**

This optional course in the third semester introduces the students to the International Organisation which has been shaping the International Trading world since 1995. The entire

subject concentrates on the World Trade Organisation which is the only global organisation dealing with the rules of trade between nations.

**COURSE OUTCOME:**

CO 1	Understand the history of rules and regulations which governed the international trading world post World War II.
CO 2	Understand the reasons for the failure of various agreements and treaties which tried to regulate international trade in 1900s.
CO 3	Study in detail the origin, formation, principles, and structure of WTO along with various special agreements signed under it.
CO 4	This course also highlights the problematic areas of WTO and encourages the students to research to finding the solutions to tackle these problems.

**Subject: 6. INTERNATIONAL TRADE LAW AND AGREEMENTS (II)**

**COURSE OBJECTIVES:**

ITL and Agreements (II) which is divided into 5 Units elaborate upon the laws, rules, regulations and conventions governing International sale of Goods. The subject exhaustively deals with finance and payment in International trade along with ways and methods of transportation, insurance and dispute settlement mechanism.

**COURSE OUTCOME:**

CO 1	Understand the complexity of International Trade and the efforts taken by various international organisations to bring about harmony in the laws governing International Trade.
CO 2	Identify the ways of generating finances for international trade and also identifying the methods of payment.
CO 3	Understand the contracts of Unimodal and Multimodal Transport and the Insurance of exports.
CO 4	Appreciate the non-judicial dispute settlement mechanism used in resolving international trade related disputes.

## **LL.M. DEGREE PROGRAM**

### **CRIMINAL LAW**

#### **GROUP - G**

#### **PROGRAMME OUTCOMES**

1. Students will be able to understand, analyse and apply criminal jurisprudence, laws and cases.

##### **Programme Specific Outcomes:**

- Students will demonstrate knowledge of substantive Criminal Law, Procedural Criminal law & Knowledge of historical background of Criminal Law.
- Hierarchy, Functions and Jurisdiction of Criminal Courts.
- Interpretation and application of Criminal Law and Case laws.
- Will demonstrate knowledge about other machineries working under Criminal Justice System like, Public Prosecutor, Police, Jail Authorities and relevant provisions of law.

##### **PROGRAMME OUTCOMES:**

2. Students will apply and utilize the Principles of Criminal law effectively in real life.

##### **Programme Specific Outcomes:**

- Students will be able to understand the significance and importance of Criminal law in day to day life and application of Criminal law to real life situations.
- Students will utilize his professional knowledge to enter into chosen professional field like, as a practicing lawyer, legislature, Judge, law officers, law Clerks, Researcher, teacher etc.

##### **PROGRAMME OUTCOMES:**

3. Research Based Learning in Law

##### **Programme Specific Outcomes:**

- Students will be in a position to understand and appreciate the National and International dimensions of various issues.

- Students will be able to indulge into Research Methodology and will be able to write research papers, policy papers etc.

**PROGRAMME OUTCOMES:**

4. Students will recognize the causes of criminal behaviour and rights of criminals as well as Victims of crime with all sensitivity and will apply common ethics to resolve these issues.

**Programme Specific Outcomes:**

- Through different theories, students will be in a position to appreciate the causes of criminal behaviour and rights of Criminals and accordingly will apply law & sentencing policy.
- The students will be sensitized towards the rights of Victims of crime and will be in a position to draw different schemes for compensation and rehabilitations of Victims.
- Students will identify and apply the Code of Ethics for Professionals while practising and especially in sentencing process.

**PROGRAMME OUTCOMES:**

5. Students will understand the problems encounter by present Criminal Justice System and will be prepared to respond accordingly.

**Programme Specific Outcomes:**

- Students will be able to evaluate the different reasons for success or failure of Criminal Justice System in Indian society and accordingly will be in a position to suggest reforms.
- Students will be able to analyse the challenges encounter by various participants in Criminal Justice System like, lawyers, Public prosecutors, Police, Judiciary and will be able to deal with the situations more effectively and efficiently.

## **COURSE OBJECTIVES & OUTCOMES**

### **1. LL.M. 1<sup>st</sup> Semester (CBCS): Principles of Criminal Law**

#### **COURSE OBJECTIVES:**

The Course is designed with an objective to make students aware about the Principles of Criminal Law and the Substantive rules at the onset. This would act as a forerunner in igniting their thought process and developing their analytical skill.

#### **COURSE OUTCOMES:**

- Having successfully completed this course student will be able to understand the historical development of criminal jurisprudence,
- Understand, explain and apply the fundamental principles of Criminal jurisprudence, specific offences and general exceptions,
- Will apply his knowledge critically to identify the problems into society and will suggest solutions to different complex issues under criminal law,
- Will identify and critically analyse the determining factors to declare a particular act or omission as criminal or non-criminal act.

### **2. LL.M. 1<sup>st</sup> Semester (CBCS): Penology: Treatment of Offenders**

#### **COURSE OBJECTIVES:**

The Course is designed keeping in view the need to disseminate information about the development of Penology, Theories of Punishment, Prison administration and sentencing policy in India. This would further develop an ability to think out of the box and question existing Penal policy in India.

#### **COURSE OUTCOMES:**

- Will be in apposition to understand the contemporary use of the correctional service, in theory and practice, in India,
- Will understand the different theories of punishment and the viability of death penalty in India and also the alternative punishments offered by restorative Justice,

- Will understand the different kinds of prisons and the model adopted in India and challenges of successful resettlement of offenders in the community after his punishment in jail and also the challenges faced by Prisons in India,
- The students will demonstrate the ability to think critically and give solutions to the existing challenges in sentencing policy, administration of prison etc.,
- Will demonstrate the ability to indulge into research activity, as they will develop written and verbal skills of analysis, Critical evaluation, comparison, interpretation, presentation etc.

### **3. LL.M. 2<sup>nd</sup> Semester (CBCS): Comparative Criminal Procedure**

#### **COURSE OBJECTIVES:**

The main objective of this Course is to impart basic knowledge about the Procedural law. The Course sheds light on the Hierarchy of Criminal Courts, Arrest provisions, Bail, Appeal, Revision etc. Legal education becomes farce unless a student is well equipped with a basic knowledge about the Substantive and Procedural laws.

#### **COURSE OUTCOMES:**

- Students will acquire deeper knowledge and will understand the procedure to be followed in Criminal Courts in India.
- Will understand the hierarchy of criminal Courts, the system of Criminal Prosecution in India,
- Will be in apposition to apply this knowledge into practice and also will be in apposition to identify and appreciate the challenges faced at procedural level and will be prepared to suggest reforms accordingly,
- Will be in position to understand the different Rights available to the accused as well the importance of Experts Evidence, provisions of Appeal and Bail & Bonds.

### **4. LL.M. 2<sup>nd</sup> Semester (CBCS) : Criminology**

#### **COURSE OBJECTIVES:**

The Course is designed with an objective that the students are acquainted with various Theories of Criminology, Schools of Criminology etc. This would develop their ability to assess the factors responsible for exhibiting criminal behaviour. The ultimate goal of this

Course is to ignite inquisitiveness in a student and also develop interest in conducting research in the field of Criminology.

### **COURSE OUTCOMES:**

After studying this subject, students will be able to;

- Exhibit adeptness in the knowledge of various Theories of Criminology.
- Understand various factors responsible for criminal behaviour and increasing criminal propensity.
- Locate, evaluate and effectively use the information on causes of crime, delinquency and various theories for rehabilitation and reformation of criminals.
- Pursue higher research in Criminology and thus, can also be a part of Policy making process designed to strengthen the Law and order machinery in India.

### **5. LL.M. 3<sup>rd</sup> Semester (CBCS) : Criminal Justice System and Human Rights**

#### **COURSE OBJECTIVES:**

The Course aims to make students aware about the importance of Human rights which are kept at the highest pedestal. This will enable them to study Human rights with multidimensional approach and to critically analyze the Criminal Justice System in India on the touchstone of Human Rights and Constitutional rights.

#### **COURSE OUTCOMES:**

After studying this subject, students will be able to;

- Understand the concept of Human rights in a comprehensive manner and with a holistic approach.
- Critically assess and analyze the Criminal Justice System in India from human rights perspective.
- Form an informed opinion about the efficacy of the Legal framework in India in protecting the rights of marginalized and vulnerable groups of the society.
- Identify the key role of various Commissions, NGO's and other Institutions in upholding the Human Rights of an accused.



**6. LL.M. 3<sup>rd</sup> Semester (CBCS): Organised Crimes, Terrorism and International Crime: New Challenges**

**COURSE OBJECTIVES:**

The Course is designed in such a way so as to enable students to understand the nature and causes of Organized crimes and their impact on the integrity and sovereignty of a Nation. The Course will also throw light upon the Laws, Institutions and preventive strategies against the Organized and International crimes as well.

**COURSE OUTCOMES:**

After studying this subject, students will be able to;

- Understand the concept, nature and causes of Organized crimes.
- Critically evaluate the Legal framework in India dealing with the Organized Crimes and at the International front for the Transnational Organized Crimes.
- Demonstrate ability in comprehending various criminal gangs, their profiles and modus operandi.
- Assess and examine the role of International Criminal Court.
- Identify possible challenges and issues pertaining to the prevention of Organized crimes and International crimes.

## **LL.B 3 YEAR DEGREE PROGRAMME**

### **PROGRAMME OUTCOMES**

Students who have studied the 3 year degree programme of Law are expected to have:

PO1. A general understanding of the nature of the laws enacted in this country and the system of administration of justice.

PO2. The ability to understand the historical background and development of various laws in a country.

PO3. The ability to understand and analyse different case laws and apply these to address diverse socio-legal problems.

PO4. The ability to analyse the law and understand its application in real life situations.

PO5. The ability to research the law in order to be able to search and cite relevant cases before the court of law.

PO6. Inculcate the necessary drafting skills required for preparing pleadings, deeds and other legal documents etc.

PO7. The ability to frame arguments in favour of their clients, to be canvassed before the court of law, learn the nuances of Court craft and court mannerisms etc.

PO8. The ability to understand the several moral and ethical dilemmas in law.

PO9. To understand the ethics of the legal profession and the duty of a lawyer to the court, to the client and to the society

PO10. To enable students to enter the legal profession or to start up an enterprise or make themselves effectively employable in diverse sectors.

PO11. Students will be in apposition to navigate, participate in and affect the practical process of law making, judicial decision making, advocacy etc.

## **PROGRAMME SPECIFIC OUTCOMES:**

1. Understand the substantive and procedural laws within the country, and apply them appropriately.
2. Understand that legal education involves a process of life-long learning owing to the dynamics of the judicial process and enactment of new laws.
3. Develop leadership and inter-personal skills to be able to give appropriate advice in various social and other issues.
4. The ability to understand the transformative potential of law and utilize it as an instrument for effecting a change in the lives of people in society.

## **COURSE OBJECTIVES AND COURSE OUTCOMES**

### **LL.B. Ist Sem. 3 Yc.: CONTRACT-I**

#### **COURSE OBJECTIVES:**

Formation of contract being mandatory for all commercial transactions accentuates the importance of the subject. It is therefore understandable that contract forms part of the group of law subjects offered to the first year students. The focus of the course is on the nature of agreement, the reason for non-enforceability of an agreement, the justification for non-performance of an agreement and the ground for awarding damages. The relevance of the old doctrines in the present circumstances will also be analysed. An important area of discussion will be the growing trend of resorting to standard form of contract. Overall the study of Contract-I will enable the students to better appreciate the need for State intervention in the formation of contract. Doctrines like promissory estoppel, Doctrine of unconscionable bargains, economic duress have been evolved through the various judgments. Thus ideologies of the judges and the subsisting socio-economic circumstances will be analysed in order to evaluate the judgments. The relevance of the old doctrines in the present circumstances will also be analysed.

#### **COURSE OUTCOME:**

The students will be able to:

1. Analyze concepts like offer, acceptance, consideration, capacity and consent.
2. Identify the fundamental legal principles behind valid contract.
3. Distinguish between enforceable contract and unenforceable contact.

4. Analyze the consequences of breach of contract and remedies available under the contract act.
5. Understand the concepts like damages and specific performance
6. Acquire problem solving technique and identify current laws, rules, and regulations.

## **LL.B. Ist Sem. 3 Yc. : LAW OF TORTS AND CONSUMER PROTECTION ACT**

### **COURSE OBJECTIVES:**

This Course on Law of Torts is designed to give the students a basic knowledge and understanding about the principles of common law. Torts indicates civil liability. It is aimed to give the knowledge about the basic duty of a human being towards another human being that, you must respect the rights of each other. It talks about different torts like negligence, nuisance, defamation etc. So this is a law which talks about very basic rules, which are essential for peaceful co-existence in a complex society. It also talks about the responsibility of government to pay compensation to the individual if he suffers from any injury due to negligent act of its servants. This subject also covers the Consumer protection Act, which is the baby of Law of Torts. This covers the objectives and Scope of CPA, Enforcement machineries under the CPA and also different remedies available under CPA.

### **COURSE OUTCOMES:**

1. They will understand the basic common law principle of 'harm', and will be in a position to correlate that to the rights and responsibilities we share in a particular society.
2. Will learn the different cases under common law, which has changed the lives of people not only in India but across the globe.
3. They will be able to critically analyse the various judicial pronouncements and apply those to day to day life.
4. Will be able to understand the professional and product liability like, medical negligence, Industrial accidents, manufacturing defects etc.
5. Another important point which students will learn is how government can also be held responsible for the negligent act of its servants.

## **LL.B. Ist Sem. 3 Yc. : CONSTITUTIONAL LAW-I**

### **COURSE OBJECTIVES:**

This course is designed to introduce the students to the basics of Constitutional Law. The students will be introduced to a brief historical background to the framing of India's Constitution, the salient features of the Constitution of India and the nature of polity established under this Constitution in India. It will also help the students understand the kind of government established, the values and commitments of this Constitution and the basic framework of governance established hereunder. It is also designed to appraise the learners of the roles to be played by different political institutions in India. It will also introduce the students to the amendment procedures and the judicial turbulence in respect of amendability of fundamental rights, that led to the evolution of the Basic Structure doctrine.

### **COURSE OUTCOMES:**

Students graduating with Constitutional Law I will be able to:

1. Understand the salient features of the Constitution of India and its identifying characteristics
2. Know the Constitutional principles and doctrines that govern Constitutional jurisprudence in India
3. Understand the different kinds of government structures and classifications
4. Know in detail about the three organs of the government and the roles they are designed to play
5. Understand how the Constitution addresses situations of national peril and danger through its prescriptions of different kinds of emergencies
6. Demonstrate an understanding about the Constitution's capacity to alter itself through amendment procedure.
7. Apply this knowledge of Constitutional Law to structure their thinking towards assessing the validity of laws.

## **LL.B. Ist Sem. 3 Yc. : FAMILY LAW-I (HINDU LAW)**

### **COURSE OBJECTIVES:**

The Main objective of this subject is to make the students to indentify and understand the scheme of ancient and Modern Hindu Law, Undivided family, Marriage, adoption, maintenance and succession under the Hindu Law. Further, the matters relating to joint family system, coparcener, karta and his powers, partition and the Hindu Religions Endowments are given in the syllabus for understanding the changes effected after the parsing of the Hindu succession Act, 1956 and other related laws. The course is framed to enable them to understand composition of Family Courts and role of NGO and Lokadalat in settling the matrimonial disputes.

### **COURSE OUTCOME:**

1. The student will be able to understand the basic elements of Hindu Law, as a basis of social welfare and social justice.
2. The students will be equipped with the knowledge about the laws relating to HUF, ancestral and separate property and its devolution.
3. It will help the student to understand the domestic relationship such as marriage, matrimonial remedies, legitimacy of children, custody, Guardianship and Adoption etc.
4. Students will understand the structure of Family Courts.
5. Endow the students with the knowledge of various sources and schools of Hindu Law.
6. The students will demonstrate the ability to market their professional skill by way of learning counseling process.
7. The students will learn to bridge the gap between law and society and make the law socially relevant by gaining knowledge about various provisions of act specially designed to protect the rights of women and children.

## **LL.B. Ist Sem. 3 Yc. : LEGAL LANGUAGE**

### **COURSE OBJECTIVES:**

This course is designed to impart basic knowledge about laws in general, its origin , classification , kinds, functions and the sources of law. The students shall be apprised of the characteristics of legal language, problems of legal language in legal writing and legal

drafting. The basics of legal terminology, maxims and fundamental principles of legal language will give students a fair idea of the nuances of legal language to be applied while drafting legal documents and writing legal opinions or analysing the case laws.

### **COURSE OUTCOMES:**

Students graduating with Legal Language will be able to:

1. Understand and describe importance of Legal Language.
2. Understand meanings and characteristics of legal language, terminology and maxims.
3. Evaluate the problems of legal language.
4. Correctly apply legal language and terminology.
5. Use and apply the fundamental principles of legal writing.
6. Understand the role of case law, precedent, and statutory and regulatory law in our legal system.
7. Develop Composition skills.
8. Drafting clear, effective, professional and well-organized objective and persuasive legal comments.

### **LL.B. IInd Sem. 3Yc. : LAW OF CONTRACT-II**

#### **COURSE OBJECTIVES:**

This course will introduce the students to different kinds of contracts like Indemnity, Guarantee, Bailment, Pledge, Agency, Sale of goods, Partnership etc. and its intricacies. This law is contained in several legislations apart from the Indian Contract Act. This course equips the students to better appreciate the legal services required in a corporate office so that he can enhance his relevance as a lawyer in society.

#### **COURSE OUTCOMES:**

1. The students will be able to know the basic principles of special contracts.
2. The students can critically evaluate conditions and warranties of Sales of Good Act.
3. The students will be able to determine the legality of transactions as well as the rights and duties of the contracting parties.
4. Students will be able to purposefully deal with the disputes arising out of contractual

arrangements and will be able to draft contractual instruments.

5. It will help the students to learn the Partnership Act and formation of Partnership firm.
6. The students will be able to understand the growing importance of new forms of special contracts including standard form of contract.

## **LL.B. IInd Sem. 3Yc. : LAW OF CRIMES**

### **COURSE OBJETIVES:**

This Course on Law of Crimes is designed to give to the students a basic knowledge and understanding about the penal law of the country. It will clarify the concept of Crime to the students so that one understand the different definitions of crime and the scope of criminal responsibility in India. It will also talk about the basic principles of Criminal jurisprudence like, Actus Reus & Mens Rea. The course will cover mostly the provisions under Indian Penal Code. This will elaborate the General Principles of Criminal Law like Punishments, Attempt, Abatement, Conspiracy, General Exceptions etc. And also will cover the Specific offences under it like, Offences against human body, Offences against Women, offences affecting public Health etc.

### **COURSE OUTCOMES:**

1. Criminal law is the means through which society expresses its condemnation for particular behaviour and therefore through Criminal Law students will be able to learn to contemplate the proper role of the state in enforcing the public morality.
2. Students will appreciate the reasons for imposition of appropriate and stringent punishments for violation of Criminal law of the Country.
3. Will understand the determinant factors responsible for laying down criminal policy of the country.
4. Will understand the different principles of Criminal jurisprudence and the specific offences under Indian Penal Code.
5. Will understand the whole scheme of General Exceptions and the scope of Criminal Liability in India.
6. Students will be sensitized towards the rights of women through different provisions for the protection of women under Indian Penal Code.



## **LL.B. IInd Sem. 3Yc. : CONSTITUTIONAL LAW-II**

### **COURSE OBJECTIVES:**

This Course on Constitutional Law is designed to give to the students a basic knowledge and understanding about Fundamental Rights and Directive Principles of State Policy which constitute a very important part of our Constitution that is committed to individual liberty and freedom. The course is framed in a way that the students not only understand the textuality of these rights but also the role played by the judiciary in the expansive interpretation of these rights. This course is also designed to highlight the Constitutional principles incorporated by the court in applying these rights

### **COURSE OUTCOMES:**

Students graduating with Constitutional Law II will be able to:

1. Understand the philosophical distinction between fundamental rights and other ordinary rights
2. Know the judicial contribution towards a broadened understanding of the concept of “State” for the purpose of Fundamental Rights
3. Appraise and analyse the scope and content of different fundamental rights guaranteed by the Constitution of India; as also the judicial trend towards expansive reading of these rights.
4. Map the change in the judiciary’s approach towards understanding the inter-relationship between Fundamental Rights and Directive Principles of State Policy
5. Acquire knowledge about how, and to what extent can fundamental rights be impacted in exigencies like National Emergency etc.
6. Get a conceptual clarity about Fundamental duties spelled out in the Constitution of India
7. Understand how the Constitution supplies a parameter of validity for all laws within the legal order.

## **LL.B. IInd Sem. 3Yc. : FAMILY LAW-II (MUSLIM LAW)**

### **COURSE OBJECTIVES:**

This Course on Muslim Law is designed to give to the students a basic knowledge and understanding about Islamic law. It will cover the basic outline about the different schools

under Muslim Law. It will also talk about the traditional and modern sources of Muslim Law. Muslim Marriage is a civil contract however the students will be in a position to appreciate as how it is a sacrament as well. It will elaborate different traditional concepts like Muta Marriage, Dower, Option of Puberty etc. Through different provisions under law and case study students will understand the different rights available to Muslim women. This will also cover the Principles and competence to inherit the property under Muslim Law.

#### **COURSE OUTCOMES:**

1. The study of Muslim law will provide an opportunity to explore the basic principles of Muslim law and also the development of Islamic law.
2. Will be in apposition to understand the different Schools and Sources of Muslim Law.
3. Will be able to appreciate the legislative schemes covering different aspects under Muslim law and will be able to apply those principles to real life situations.
4. Will be able to critically evaluate the application of traditional Muslim law in a Present Scientific era like, Maintenance, triple talaq, polygamy etc.
5. Will be in a position to evaluate theoretical concepts and practicalities of the system of law which governs the Islamic way of life.
6. Will sensitize students about the Rights of Muslim women and will help students to research on Comparative aspects of different personal laws.

#### **LL.B. IInd Sem. 3Yc. : COMPANY LAW**

#### **COURSE OBJECTIVES:**

Industrialization plays a very vital role in the economic development of India. Companies are no doubt powerful instruments for development besides bringing returns and financial benefits to the capital purposes. The course is designed to understand the formation, management and other activities of the companies. Important regulations pertaining to the issue of shares and the capital raising have come into force. This course aims to impart the students, the corporate management, control, possible abuses, the remedies and government regulation of corporate business and winding up. This course is framed to explain the formation of a company and capital formation of a company.

## **COURSE OUTCOME:**

The students will be able to:

1. Appraise new concepts involving information about formation of different kinds of companies and concept of corporate personality.
2. Acquire knowledge about the provisions of Companies Act, 2013
3. Understand the process of formation and incorporation of a Company, Rules and procedures for administration of company.
4. Understand the relationship between company and shareholders and debenture holders.
5. Understand the role of independent directors in corporate governance.
6. Find out the process of winding up of a company and regulation of corporate business.
7. Understand the corporate social responsibility.

## **LL.B. IIIrd Sem. 3Yc. : JURISPRUDENCE**

### **COURSE OBJECTIVES:**

This course has been designed to develop the skill of critical legal thinking by furnishing them with the philosophical foundations of Law. It takes them through different theories of jurists, especially from the Western philosophical tradition to give them a refreshed understanding about the concept of law as well as other legal concepts. This course is thus designed to give to students a panoramic view of the law and to develop their legal acumen.

### **COURSE OUTCOMES**

Students graduating with Jurisprudence will be able to:

1. Understand and analyse the philosophical foundations of law and legal concepts.
2. Gain knowledge about different approaches to defining the “Law” and legal concepts
3. Understand the different roles that law has to play and the diverse ways in which law influences the society and society influences the law.
4. Understand the different sources from which law emanates.
5. Understand the relationship of Law with morality, justice etc, thereby equipping them with the capacity to be able to do a moral assessment of law.
6. Demonstrate the intellectual capacity and an enhanced acumen to critically analyse the law.

## **LL.B. IIIrd Sem. 3Yc. : LABOUR LAW-I**

### **COURSE OBJECTIVES:**

This course develops students' knowledge and understanding of labour relations as well as essential labour laws governing terms and conditions of employment, with particular reference to India. The form and structure of legal regulation of employer-employee relations is influenced by historical, economic and political factors. Students will be expected to gain an understanding of the various factors in the industrial relations system, the institutional relationships among the actors, and some of the norms and rules that are developed within the labour law system as well as through the jurisprudence evolved by the judiciary.

### **COURSE OUTCOMES:**

At the end of this course students would be able to:

1. Demonstrate an appreciation of the industrial, economic and social contexts in which labour is regulated;
2. Demonstrate an understanding of the significance and content of the contract of employment and its relationship to industrial awards and workplace agreements;
3. Demonstrate an understanding of anti-discrimination law and law regulating occupational health and safety;
4. Describe the role of the Constitution in the federal system of industrial relations;
5. Demonstrate an understanding of the operation of the conciliation and arbitration, the nature and significance of awards, the legal regulation of workplace agreements and the provision of minimum terms under industrial legislation;
6. Demonstrate an understanding of the role of law in regulating industrial conflict;
7. Demonstrate an understanding of the legal regulation of trade unions;
8. Demonstrate the skills required in applying legal rules and principles in the context of case laws and judicial evolution of labour laws;
9. To demonstrate an intellectual capacity for solving industrial disputes..

## **LL.B. IIIrd Sem. 3Yc. : ENVIRONMENTAL LAW**

### **COURSE OBJECTIVES:**

Law and policy plays a major role in the conservation and management of natural resources as well as in abatement and control of environmental pollution. This present course on

environmental law intends to introduce the students to the vast field of Environmental Law and Policy in India as well as at the international level. The course explains the role of law, policy and institutions in the conservation and management of natural resources as well as pollution control. It covers the laws and policies both at the national and international level relating to environment. This course will inculcate amongst the students a spirit of inquiry to explore the development of international environmental law and its application in India for the protection of environment.

### **COURSE OUTCOMES:**

1. I will make the students aware about the provisions under the Indian Constitution for protection of environment and the various legislative measures. It also provides an opportunity to the students to understand the activist role played by Indian Judiciary in protection of environment and evolution of different principles such as polluter pay principle, precautionary principle, inter-generational equity, Public Trust Doctrine and sustainable development.
2. At the end of the course it is expected that the students would be familiar with the overall Environmental Law and Policy regime of the country as well as its international obligations.
3. The case studies would equip them with basic knowledge and skills to understand and articulate the environmental law and policy issues.
4. To students would understand the multidisciplinary nature of environmental issues and would better equip them with the skills to interpret the laws, policies and judicial decisions.

### **LL.B. IIIrd Sem. 3Yc. : TRANSFER OF PROPERTY**

#### **COURSE OBJECTIVES:**

The course framed with the object to know the concept of 'property' and the nature of property right are basic to the understanding of law relating to property. This course will study the concept in particular, its contemporary emphasis, on 'user', the evolution of the right to transfer property and the limitations operating thereon as laid down in the Transfer of Property Act. Necessary references will be made to the English law as well as to the doctrines of equity which have been responsible for the crystallization of the basic principles and

doctrines of property law. The general principles and the provision on various modes (Lease, Mortgage, Sale, Gift and Exchange) relating to transfer of property will be studied.

**COURSE OUTCOMES:**

1. The course takes the students through the meaning and concept of property, historical background of transfer of property, various kinds of property with special reference to the subject matter of Transfer of property that is immovable property.
2. The course enables the student to study the Transferable and non-transferable property
3. It provides the detail emphasis on the various doctrines regarding the conveyance of the immovable property.
4. The course enables to study the various provisions on the different modes of the transfer of immovable property like sale, mortgage, lease, gift and exchange.
5. With the various modes it enhance the understanding the rights and liabilities of the transferor and transferee under various modes of conveyance.

**LL.B. IIIrd Sem. 3Yc. : COMPUTER THEORY& PRACTICAL**

**PROGRAMME OBJECTIVES:**

The course basically deals with the fundamentals of computers, data communication, networking and Internet. Understanding computer and web based technology is becoming a pressing requirement for proper understanding and application of law relating to computer and internet. With the plan in mind the course intends to provide to students, an understanding Computer fundamentals, an understanding of various data communication systems, Knowledge of various Web based technologies and an understanding of working of Internet.

**PROGRAMME OUTCOMES:**

After the successful completion of the course, the student will be able to,

1. Understand and describe computer fundamentals including the assembly of computer, the concepts of memory & storage, software and applications, types and generations of computers etc.

2. Describe the types data communication systems.
3. Analyze various networking systems
4. Illustrate the working of internet and other web based technologies.

### **LL.B. IVth Sem. 3Yc. : ADMINISTRATIVE LAW**

#### **COURSE OBJECTIVES:**

The course enriches the students with the basic Principles of Administrative Law including quasi-legislative, quasi-judicial and other ministerial functions of administration and control thereof with a practical approach. This course also aims at studying the notions like Administrative Discretion and Delegated legislation, where it reflects the due diligence on the part of administrative authorities while taking any action.

#### **COURSE OUTCOMES:**

1. The course will make students receptive of various aspects of Administrative and appreciate how judiciary controls the various administrative authorities through judicial review.
2. It will assist students in examining the tortious and contractual liabilities of the State for seeking relief from government, its agencies and instrumentalities through different kinds of writs.
3. It will enable to explore the various concepts like Rule of law, Theory of Separation of powers, and its applicability in modern day.
4. It gives students insight into principles of administrative law like Natural justice, promissory estoppel, legitimate expectation, doctrine of proportionality.
5. Through this course the students will be able to demonstrate the scope and functions of various Parliamentary committees, Commissions of Inquiry, Administrative Tribunals and Central Vigilance Commission.

### **LL.B. IVth Sem. 3Yc. : INTELLECTUAL PROPERTY LAW**

#### **COURSE OBJECTIVES:**

The course has been designed to study the novel avenue of the typical kind of intangible property in the name of Intellectual property. This course aims to study the existing (copyright, patent, trademark and designs) and emerging (computer software) forms of

intellectual property in terms of Indian law and policy as well as new international demands and trends. Besides, the course will examine the philosophical foundations of recognizing intellectual property rights, its relation with public interest and socio-economic development and the demands of equity and compulsions of international trade.

#### **COURSE OUTCOMES:**

1. The course enhances the cognitive domain of the student regarding the meaning of Intellectual property and its nature and types.
2. The course divides the study of the student to go through the respective IP laws enacted for separate IP by the legislature.
3. It provides the knowledge regarding the different subject matter falling under the respective field of intellectual property.
4. The course emphasis on the term of protection to different IP laws, the right of IP holder, Process of the registration.
5. It also provides the various instances of the infringement of Intellectual property.
6. In order to enable the practical knowledge to the student, it provides the plethora of the famous and landmark case with respect to all Intellectual property laws.

#### **LL.B. IVth Sem. 3Yc. : LABOUR LAW-II**

#### **COURSE OBJECTIVES:**

This course develops students' knowledge and understanding of Social Security and Social Insurance provided to workers as well as essential welfare legislations governing terms and conditions of social insurance and social security, with particular reference to India. The form and structure of legal regulation of employer-employee relations is influenced by historical, economic and political factors. Students will be expected to gain an understanding of the various factors in the social security system, the institutional relationships among the employers and employees, and some of the norms and rules that are developed within the labour law system as well as through the jurisprudence evolved by the judiciary.



## **COURSE OUTCOMES:**

By the end of this course, students should be able

1. To understand the nature and scope of Social Security and Welfare Legislations.
2. To describe the rationale of providing social security to the labour in organizations.
3. To identify all aspects of Labour welfare Legislations practiced in India.
4. To exhibit a comprehensive theoretical and practical understanding of Welfare legislations and Laws related to workers.
5. To demonstrate an intellectual capacity for solving workmen disputes relating to Social Security and Social Insurance.

## **LL.B. IVth Sem. 3Yc. : PUBLIC INTERNATIONAL LAW**

### **COURSE OBJECTIVES:**

The objectives of this course is to accustom students with fundamentals of Public International law and update them with the latest development. The study of this course helps students in exploring the various methods through which the State is recognised as well as modes through it may lose its existence. It also focuses on the study of relationship of individual with the State in international scenario. It also aims at enriching the students with new evolving aspects like Conventions such as Outer space Treaty, Moon Treaty and the Law of the Sea.

### **COURSE OUTCOMES:**

1. This course will assist to acquaint the students with basics of Public International law and how it is related to Municipal law.
2. It will be helpful to update them with the latest international treaties and conventions.
3. It will make the students aware of various concepts like Extradition, Asylum and other related terms which will enable them to co relate with recent incidences.
4. It enables students of international laws to specialize in the subject by having a detailed study of the purpose and functioning of different international organizations and their agencies.
5. It also aids in analysing Contemporary Issues in different parts of world.

## **LL.B. IVth Sem. 3Yc. : BANKING LAW**

### **COURSE OBJECTIVES:**

The banking industry in India is one of the advanced sections of Indian economy. The legal framework even after nationalization has provided so much scope for competitive development that it deserves to be studied in context in the law curriculum. This course aims to study banking law and practice in the perspective of the changing trade and investment scenario of the country with special reference to Securitization Act, 2002 and Law relating to Negotiable Instruments, 1881 Act.

### **COURSE OUTCOMES:**

1. The course takes through the student the concept of Indian banking system, origin and evolution of banking.
2. It provides the study of Employment of funds, Loans and Advances, Guarantees, Financing of Exports, Special Banking Services, Advances to Priority Sectors and Credit Guarantee schemes with special reference to Securitization Act, 2002.
3. The course enables the student to study the Law relating to Negotiable Instruments, 1881 Act.
4. It provides the emphasis on the banker customer relationship with specific provision on the banker's duty.
5. The course enhances the understanding of the student with regard to Special types of customers.
6. It further throws the knowledge with respect to ancillary services and e- banking with the importance of banking ombudsman.

## **LL.B. IVth Sem. 3Yc. : INSURANCE LAW**

### **COURSE OBJECTIVES:**

Insurance is a very technical subject. So, while dealing in insurance matters, finance professional or an investor should understand the basic concepts and principles of insurance. This subject course thus designed to enable the students to understand the need of studying principles of insurance. It covers meaning of insurable interest in insurance agreements and its importance, meaning of indemnity and its importance in insurance claims , Meaning of 'Uberrimaefidei' and its use in Insurance contracts. Study focuses on various laws and regulations related to general insurance business in India.

**COURSE OUTCOME:**

1. Acquire specialized knowledge of law and practice relating to Insurance
2. Study the principles and practice of general insurance claims.
3. Understand the legal procedures to be followed for processing a claim.
4. Study the importance of evaluating and assessing genuine claims.
5. To know the concept of Marine insurance and its types.
6. Understand the features of different types of Liability insurance.
7. Understand the essentials of a valid insurance contract.
8. Analyze the meaning and significance of the principle of Life insurance.

**LL.B. Vth Sem. 3Yc. : CIVIL PROCEDURE CODE AND LIMITATION ACT****COURSE OBJECTIVES:**

The main objective of the said subject is that to sets out the rules and standards that Courts should follow while adjudicating the civil law suits. It helps the parties to understand the ways and means by which their rights and liabilities can be enforced. The course study and analyze and explains the competent and jurisdiction of civil courts. It further analyze the law relevant to initiating and responding the suit filed between the parties in court. It defines the area of remedies in civil litigations matters, and explains in precision manner regarding the draft, pleading and discovery of documents in proper court format.

**COURSE OUTCOMES:**

1. The course on Code of Civil Procedure helps the students to learn and deal with the procedure laws which lays down the ways and means by which the substantive law can be enforced.
2. The provisions dealt in Code of Civil Procedure will help the students to differentiate substantive and procedural law and explain the inter-relationship between the two areas when the students steps out in practice.
3. The subject consolidates all the procedure to be followed by the Civil Courts in Civil Litigations. It explains the structure of civil court organization. The Code of Civil Procedure is a general law and will not affect the local or special laws which are already in force. In case any conflict with the local or special laws, the local and special law will prevail over the Code of Civil Procedure.

4. It helps the students to learn the Stages, Kinds and requirement to interpret the rules while conducting Civil litigations in Courts and further helps to solve the legal problems related to the requirement of the case when the students steps out in practice

### **LL.B. Vth Sem. 3Yc. : CRIMINAL PROCEDURE CODE, PROBATION OF OFFENDERS ACT AND JUVENILE JUSTICE ACT**

#### **COURSE OBJECTIVES:**

The course is designed to acquaint the students with the procedural laws. The course sheds light on the Hierarchy of Criminal Courts, provisions relating to arrest, bail, appeal, revision etc. The main objective of this course is to make the students capable to demonstrate proficiency in the knowledge of procedural laws.

#### **COURSE OUTCOMES:**

1. This course is meant to be an overview of the Code of Criminal Procedure, 1973 which helps the functioning of the criminal justice system.
2. The course elaborately deals with procedure to be followed by the police, the courts and other stakeholders when a crime has been committed
3. The course includes Constitutional perspective, rights of arrested and accused persons and principle and importance of fair trial.
4. Additionally the course gives special attention to the procedure to be followed for juveniles under Juvenile Justice Act, 2000 and Probation of Offenders under Probation Of Offenders Act, 1958.
5. The course will study and analyse complex issues arising out of the provisions of the code and apply same in practice.

### **LL.B. Vth Sem. 3Yc. : LAW OF EVIDENCE**

#### **COURSE OBJECTIVES:**

It has very crucial role to play in determining the rights and liabilities of the parties in litigation. It is very important medium for the implementation of substantive and procedural laws. Before entering the world of legal profession it is extremely necessary for every law student to understand the dynamics and inherent technicalities of the law of evidence. The

knowledge of various provisions like taking chief and cross of witnesses, circumstantial evidence, various case laws on corroboration in dying declaration is important.

**COURSE OUTCOMES:**

1. This course will give good understanding of the elementary principle of the law of Evidence as laid down in Indian Evidence Act, 1872.
2. The course will discuss the various principles and doctrine as given under the act and as interpreted by the courts.
3. The course aims at the developing the capabilities to understand and apply the general principles such as relevancy and admissibility, burden of proof, presumptions and questioning of person.
4. The course also aims at critical study of doctrine and principle of Res Gestae, plea of alibi, dying declaration etc.

**LL.B. Vth Sem. 3Yc. : ALTERNATIVE DISPUTE RESOLUTION**

**COURSE OBJECTIVES:**

The course aims at providing an overview of how Alternative Dispute Resolution has become the primary means by which cases are resolved now days, especially commercial, business disputes. It has emerged as the preferred method for resolving civil cases, with litigation as a last resort. The course also focuses on an introduction to Arbitration and conciliation proceedings apart from the traditional negotiation and mediation theory.

**COURSE OUTCOMES:**

1. This clinical course will assist the students in demonstrating the various skills and techniques of Alternative Dispute Resolution especially in commercial, business disputes.
2. Alternative Dispute Resolution will aid the students in application of the statutory provisions of the relevant Act and use case law emphasizing these processes during litigation.
3. This course will make the students skilled not only in litigation but also in problem-solving through negotiation and mediation, which costs the clients less in terms of time and money.

4. Through this course the students will be well versed in conducting the proceedings of LokAdalats, Family Courts and Tribunals.
5. The students will also be able to reflect the arbitration proceedings in their practice as an alternative to traditional court practice.

## **LL.B. Vth Sem. 3Yc. : PROFESSIONALETHICS & PROFESSIONAL ACCOUNTING SYSTEM**

### **COURSE OBJECTIVES:**

The present subject, 'Professional Ethics, Accountancy for Lawyers', is one of the most important branches of law prescribed for studying as a compulsory subject. Among all professions legal profession is the noblest. For sound and effective system of the administration of justice, there must exist, well organised system of Courts and well developed system of law. These two postulates are necessary to deliver pure and impartial justice. It is rightly said that, "Bench and Bar are the two wheels of chariot of justice", hence an advocate is required to know the ethics in the profession. Non-compliance to the professional ethics by an Advocate amounts to the professional misconduct, which renders Advocate unfit to continue the profession.

### **COURSE OUTCOMES:**

1. To understand the contempt law in India and the classifications of contempt, the punishments and remedies etc.
2. It involves practical training and involves case studies by the students and case presentations in the class.
3. Acquaint the students with general principles of accounting.
4. The students will be able to understand the historical evolution of the legal profession as well as the various codes of conduct and ethical norms for the advocates.
5. Introduce the professional accountability concept to budding lawyers.
6. Impart an idea on the professional accounting system for lawyers

## **LL.B. Vth Sem. 3Yc.: CYBER LAW**

### **COURSE OBJECTIVES:**

The development of Information technology has developed the Communication. The course thus deals with all the aspects of Cyber law and deals with Indian IT act 2008. It covers the various aspects of Cyber crime. It also covers overview of Intellectual Property Right and Trademark Related laws with respect to Cyber Space. The course aims to give in depth knowledge of Information Technology Act and legal frame work of Right to Privacy, Data Security and Data Protection. It covers other cyber crimes that are taking place via the Internet.

### **COURSE OUTCOMES:**

1. Students identify and analyse statutory and regulatory laws in the field of Information technology and apply diverse view point to recommend appropriate actions.
2. Develop basis understanding about cryptology and key encryption techniques used.
3. Provide an understanding of concepts relating to information security.
4. Develop the knowledge of Information Technology Act.
5. Give in-depth knowledge about the legal framework of cyber crime and cyber offences.
6. To inculcate the significance of cyber Law, E - commerce, legal social and international issues and remedies available under IT Act.
7. To enable the students to understand the digital signature.
8. To explore overall legal IP issues and cyberspace.

## **LL.B. Vth Sem. 3Yc. : RIGHT TO INFORMATION**

### **COURSE OBJECTIVES:**

The course aims at emphasising the importance of Fundamental Right to Information in democracy. It also focuses on the study of necessity of having a comprehensive enactment on right to information. It enhances the knowledge of students with regard to role of Public Information Officer and their Duties and Onus on the PIOs. It also emphasises on the role of Civil Society Organisations and Media for Good Governance.

## **COURSE OUTCOMES:**

1. This course will be helpful in acquiring comprehensive knowledge of the provisions of the RTI Act, 2005 and its general applicability in day to day affairs while dealing with governmental agencies.
2. It will make the students analyse the roles and responsibilities of government officers concerned while implementing the law and enforcing the rights of the citizens.
3. Through this course the students will be able to evaluate the remedies available to a citizen whose right is infringed due to non-compliance of the said Act.
4. The students will also study decisions rendered by State Information Commissions and Central Information Commission relating to different Government Departments.
5. It will be able to express the importance of records management for Effective Information through Best practices

## **LL.B. VIth Sem. 3Yc. : INTERPRETATION OF STATUTE**

### **COURSE OBJECTIVES:**

This course introduces students to various theories of judicial process and canons of statutory interpretation. The aim of the course is to enable students to understand and apply various rules of interpretation. The course will also engage with various judicial approaches towards the use of canons of construction and the implications of these approaches.

This course is relevant to the understanding of statutory interpretation and judicial process in all other law courses. The course also holds relevance for legal practice by students in future as it aims to improve legal argumentation. Students will learn how to channel their legal arguments through the use of rules of interpretation, thus learning how to draft good legal memos as lawyers or write sound judgments as judges.

The course will also engage with various aspects of legislative drafting. A study of the canons of construction and their judicial interpretation will reveal how ambiguities in the statute create difficulties in interpretation. Further, there are inherent limitations of the legislature and the law making process. Aiming to develop an awareness of these limitations and an understanding of the rules of interpretation, the course will encourage students to critically think about better ways of drafting legislative provisions so as to give better guidance to the persons it applies to, law enforcement officers and judges.



## **COURSE OUTCOMES:**

Upon successful completion of the course, students will have the knowledge and skills to:

1. Make students aware of the need for statutory interpretation given the imprecision of language and impossibility of anticipating all future events.
2. Introduce students to various theories of interpretation.
3. Enable students to understand and apply various canons of statutory interpretation followed in the common law legal system.
4. Explain, distinguish and apply the principles and process of statutory interpretation
5. Select and apply a range of legal research principles and methods in interpreting legal instruments.

## **LL.B. VIth Sem. 3Yc. : LAW OF TAXATION**

### **COURSE OBJECTIVES:**

The course on taxation which includes direct tax and indirect tax both helps students to understand the basics of taxation regime following in India. The main objective of this subject is to expose the students to the various provision of Income Tax Act- relating to computation of Income of individual assesses, to understand about the Indirect taxation system following in India in Business and profession.

### **COURSE OUTCOMES:**

- Helps students to start their own profession in the field of Taxation.
- Analysis and deep study about the revenue generation system through taxation by Indian government.
- Helps to understand the conceptual and practical aspect in Taxation.
- Revenue from taxation to the government is the major area on which our Indian economy is based.
- It learns Students to compute and assess the tax on income of individual, company etc.

## **LL.B. VIth Sem. 3Yc. : LAND LAWS**

### **COURSE OBJECTIVES:**

The subject, Land Laws incorporates basic land laws viz, Maharashtra Land Revenue Code 1966, The Maharashtra Regional and Town Planning Act,1966 and Land Acquisition Act, 1894. The main objective is to make students understands the law regarding acquiring of land of others, the power of government to acquire land and rules regarding fixation of compensation for acquiring of land. The object is to understand the constitution of Regional Town Planing Board, its duties and powers, the procedure for preparing and sanctioning the development plan but also the effects of unauthorized developments. The object is also to know various shortcomings in the existing legal regime in this regards. The present subject Land Laws incorporates basic land laws that is Maharashtra Land Revenue Code 1966, The Maharashtra Regional and Town Planning Act,1966 and Land Acquisition Act, 1894. The Land Acquisition Act gives the procedure for acquisition and compensation with reference to same. Along with said laws the study also includes details regarding Classification of lands.

### **COURSE OUTCOMES:**

1. The said subject makes the students aware about the law to acquire land of others. It makes students understand that the power of government to acquire land is not absolute. The course will study and analyze about the rule regarding compensation for acquisition of land. The study of the present subject makes the student aware about the laws regarding Land and Land revenue which are in force in different parts of state of Maharashtra.
2. The study helps the students aware about the constitution of Regional Town Planning Board, its duties and powers. The study not only makes student understand the procedure for preparing and sanctioning the development plan but also the effects of unauthorized developments.

## **LL.B. VIth Sem. 3Yc. : DRAFTING, PLEADING & CONVEYANCING**

### **COURSE OBJECTIVES:**

The course is designed to acquaint students with the general principles of Drafting and relevant Substantive Rules. The another objective is to make students able to draft Petition, Complaint, Written Statement and miscellaneous Application. Apart from this the students will also learn to draft various deeds. This course is important in legal education as it equips the law students with basic legal knowledge and drafting skills.

## **COURSE OUTCOMES:**

Students will be able to-

1. Learn the art of legal drafting means the art of composition or writing of all legal documents, dealing with or affecting legal rights.
2. Distinguish the art of legal composition from the art of ordinary composition of literature.
3. They will understand the basics and distinction between drafting, pleading and conveyancing.
4. Practical part of the subject will develop a general critical approach to the new law and to problem solving.
5. Will help inn legal practice, as this will bring the relevant questions before the Court for successful adjudication.

## **LL.B. VIth Sem. 3Yc. : MOOT COURT & INTERNSHIP**

### **COURSE OBJECTIVES:**

This is a compulsory clinical paper which focuses on the developing of the advocacy skills through Moot Court Pre-Trial Preparation and Participation in Trial Proceedings. This course aims at making students well versed in the written submissions in the form of Civil case, Criminal Complaints and Writ petitions in general and to develop oral advocacy skills through these Moot trials.

### **COURSE OUTCOMES:**

This course enables the students to—

1. Participate in at least three moot courts which will be based on an assigned problem.
2. Prepare written submissions which includes brief summary of facts, issues involved, provisions of laws and arguments, citation, prayer, etc.
3. Develop the skill of oral advocacy which emphasises on communication skills, presentations, language, provisions of law; authorities quoted, court manners, etc.
4. Present Written Memorials based on two cases, one Civil and one Criminal.
5. Inculcate the interviewing techniques and Pre-Trial Preparations through Internship in Lawyer 's office or in the Legal Aid Office and Court Visits.

## **LL.B. VIth Sem. 3Yc. : HUMAN RIGHTS**

### **COURSE OBJECTIVES:**

The objective of this course is to make students aware of the principles of international humanitarian law and enable them to specialize in the field of Human Rights Law. The course helps in upgrading the knowledge of students with regard to Human rights of Disabled Persons, Indigenous persons, Persons with HIV – AIDS. It also focuses on the study of Child Rights Convention, Convention against Slavery, Convention on Refugees and other related international covenants enhancing the scope of Humanitarian Law.

### **COURSE OUTCOMES:**

1. The course will assist the students to understand the evolution of Human rights and how it is incorporated in various international conventions and domestic legislations.
2. This course will help to acquaint the students with basic human rights institutions.
3. The course will also be able to enhance the critical skills to equip the students with various aspects of Human rights violations.
4. The students will be aware of the principles of international humanitarian law and enable them to specialize in the field of Human Rights Law.
5. It will also assist students to take Project on working of relevant Human Rights Commission and study on incidence of Human Rights Violation.

## **LL.B. VIth Sem. 3Yc. : WOMEN AND LAW**

### **COURSE OBJECTIVES:**

The course on women and law walks the students through specific laws that deal with the provision of security, protection and protective discrimination of women. The course is divided to include the laws that provide physical, personal and mental protection to women who are discriminated against and the women who are marginalised in the society. The course will Study and analyze, what are the legal provisions enacted to ameliorate these situations with special emphasis on Indian Municipal Law and what is the scope and shortcomings in the existing legal regime in this regard?

## **COURSE OUTCOMES:**

Students graduating with Women and Law will be able to:

1. Apply a systematic approach to eliminate on the ideas in the institutions which marginalize, subordinate and accord secondary citizenship to women and underestimate or makes the women's contribution invisible.
2. Analyse the laws that specifically govern the protection of women and accord them social security.
3. Identify and discuss issues related to women and girl child at rural and urban areas vis a vis the protection mechanism provided by laws and the judicial system.
4. Understand the new legislations that provide protection to women at the domestic level as well as at workplaces.
5. Analyse the efficacy of laws that prevent discrimination of women.

## **B.A.LL.B 5 YEAR DEGREE PROGRAMME**

### **PROGRAMME OUTCOMES**

Students who have studied the 5 year degree programme of Law are expected to have :

PO1. A general understanding of the nature of polity established, the laws enacted in this country and the system of administration of justice.

PO5. The ability to research the law in order to be able to search and cite relevant cases before the court of law.

PO6. Inculcate the necessary drafting skills required for preparing pleadings, deeds and other legal documents etc

PO7. The ability to frame arguments in favour of their clients, to be canvassed before the court of law, learn the nuances of Court craft and court mannerisms etc

PO8. The ability to understand the several moral and ethical dilemmas in law.

PO9. To understand the ethics of the legal profession and the duty of a lawyer to the court, to the client and to the society

PO10. To enable students to enter the legal profession or to start up an enterprise or make themselves effectively employable in diverse sectors.

#### **PROGRAMME SPECIFIC OUTCOMES:**

Understand the substantive and procedural laws within the country, and apply them appropriately.

Understand that legal education involves a process of life-long learning owing to the dynamics of the judicial process and enactment of new laws.

Develop leadership and inter-personal skills to be able to give appropriate advice in various social and other issues

The ability to understand the transformative potential of law and utilize it as an instrument for effecting a change in the lives of people in society

## B.A. LL.B. I SEMESTER 5 YC

### Subject: 1.English- I

#### COURSE OBJECTIVES:

The course of English for the Law students walks them through specific learning of the language that deals with the basic understanding of the syntax, phonetics and grammar. The course is divided into different sections which include prose, poetry and grammar as well as other topics like comprehension and composition. The course will study and analyze how to develop communication skills and what is the scope of development in the language and how it will benefit the student in their future endeavor.

#### COURSE OUTCOME:

CO 1	This will enhance the understanding of English short stories and their relevance with emotion and psychology.
CO 2	This course of poetry will give them an idea of imagination and understanding the process of poetry creation
CO 3	This is more of formal communication skills where students will learn the basics of letter writing and drafting.
CO 4	The vocabulary will enhance the communication skills specially the verbal communication
CO 5	This course will help them to learn the basics of Grammar and their end uses.

### Subject: 2.Philosophy- I

#### Course Objective:

The essential feature which distinguishes man from other creatures is his ability to reason. The reasoning ability is revealed when men infer, argue or demand proof. The main task of logic is to distinguish correct reasoning from incorrect. The course is designed to understand fundamental principle of thought and the rules governing validity of the argument.

#### COURSE OUTCOME:

CO 1	By nature we are blessed with power and reasoning. Logic is the study of the use of these powers. By virtue of Logic student will increase the thought process, reasoning ability and adaptability in day to day life.
CO 2	Students will understand the basic important concepts of logic such as proposition, categorical proposition and inference syllogism.
CO 3	Students will make use of methods, techniques and principles to distinguish correct from incorrect reasoning.
CO 4	Students will develop the skill in judging the validity of an argument.
CO 5	Students will be able to understand non formal fallacies which are committed due to wrong use of terms ,rules in exception and irrelevant premises .
CO 6	The study of Logic will be permanent contribution to ones intellectual life.

### **Subject: 3. History – I**

#### **COURSE OBJECTIVES:**

The course is designed to make the students aware about the sources of early ancient Indian history. Enable the students to know the evolution of political structure and kingship, duties of a King and Checks on his Powers. Enable the students to get to know the reform of the religion and ensures the progress of language, literature and art and architecture.

#### **COURSE OUTCOME:**

CO 1	Understand the Mourya Vedic and Gupta administration in ancient India
CO 2	Identify the cultural synthesis and religious movements in ancient India
CO 3	Analyze the judicial administration
CO 4	Gain insight into historical monuments and cultural and social heritage of ancient India
CO 5	Get an insight into nature, aims and functions of the state
CO 6	Understand the literary and archeological sources of ancient Indian History

### **Subject: 4. Economics –I**

#### **COURSE OBJECTIVES:**

1. To able to understand basic concepts of economics.
2. To able to analyze economic behavior in practice.
3. Understand the economic way of thinking.
4. The ability to analyze historical and current events from an economic perspective.
5. The ability to write clearly expressing an economic point of view.
6. Be exposed to alternative approaches to economic problems through exposure to coursework in Legal fields.
7. To create students ability to suggest of the various economic problems.

#### **COURSE OUTCOME:**

Co 1	On completion of the Semester, Students will be able to demonstrate knowledge of the laws of supply and demand and equilibrium
Co 2	By the end of the course, students will be able to apply supply and demand analysis to examine the impact of government regulation.
Co 3	By the end of the course, students will be able to explain and calculate price elasticity of demand and other elasticities.
Co 4	By the end of the course, students will be able to demonstrate an understanding of producer choice, including cost and break-even analysis.



## **Subject: 5. Political Science – I**

### **COURSE OBJECTIVES:**

The course of Political science inscribes on the student of political science the importance of relationship between an individual and the State. It aims at understanding the basic concepts, theories and functioning of State. The course focuses on inculcating amongst students how the government and its agencies operate in the society. It also gives a brief insight into fundamental aspects of Constitutional Law and Administrative Law.

### **COURSE OUTCOME:**

CO 1	This course will enable the students to understand the basic concepts like State, Society, Association, Government, Democracy and Nation.
CO 2	It enables the students to examine the theory of Sovereignty and Pluralism.
CO 3	They would be in a position to evaluate the Characteristics of good Constitution and be able to make country wise classification of Constitution in the form of Written- Unwritten and Rigid-Flexible.
CO 4	The students will also be able to analyse the political ideas of Karl Marx and Mahatma Gandhi.
CO 5	The course thus attempts to evaluate the theories of political science and functioning of State.

## **Subject: 6. Law of Contract – I**

### **COURSE OBJECTIVES:**

Formation of contract being mandatory for all commercial transactions accentuates the importance of the subject. It is therefore understandable that contract forms part of the group of law subjects offered to the first year students. The focus of the course is on the nature of agreement, the reason for non-enforceability of an agreement, the justification for non-performance of an agreement and the ground for awarding damages. The relevance of the old doctrines in the present circumstances will also be analysed. An important area of discussion will be the growing trend of resorting to standard form of contract. Overall the study of Contract-I will enable the students to better appreciate the need for State intervention in the formation of contract. Doctrines like promissory estoppel, Doctrine of unconscionable bargains, economic duress have been evolved through the various judgments. Thus ideologies of the judges and the subsisting socio-economic circumstances will be analysed in order to evaluate the judgments. The relevance of the old doctrines in the present circumstances will also be analysed.

### **COURSE OUTCOME:**

CO 1	Analyze concepts like offer, acceptance, consideration, capacity and consent.
CO 2	Identify the fundamental legal principles behind valid contract.
CO 3	Distinguish between enforceable contract and unenforceable contract.
CO 4	Analyze the consequences of breach of contract and remedies available under the contract act.
CO 5	Understand the concepts like damages and specific performance.
CO 6	Acquire problem solving technique and identify current laws, rules, and regulations.

## **B.A. LL.B. II SEMESTER 5 YC**

### **Subject: 1.English- II**

#### **COURSE OBJECTIVE:**

The course of English-II for the Law students guides them through learning ability of the language and phonetics. They will learn the nuances of spoken English through phonetics. The course will study and analyze how to develop communication skills and use it in future for their legal acumen.

#### **COURSE OUTCOME:**

CO 1	This course will give the basic understanding of facts about English and Phonetics.
CO 2	The poetry portion will give them a journey into the world of fantastic imagination and understanding of Figure of Speeches.
CO 3	This unit will give an idea of developing and creating scripts through dialogue writing.
CO 4	This unit will enhance the use of Floral language through Idioms and Phrases
CO 5	This course of grammar will give them the basic idea of conversion of sentences from Simple to Compound to Complex.

### **Subject: 2. Philosophy- II**

#### **COURSE OBJECTIVE:**

The main aim of the course is to determine the validity of the argument. To enable the students to make precise and flawless argument, the new symbolic approach is developed. With the symbols arguments can be formulated with precision.

### **COURSE OUTCOME:**

CO 1	The theory of declaration aims to provide techniques for the analysis and appraisal of deductive arguments.
CO 2	Students will understand the need of symbolic logic.
CO 3	Students will formulate the argument using symbols with precision
CO 4	Students will learn to distinguish valid argument from invalid by using certain decision procedure.
CO 5	The students will be able to demonstrate the correctness of arguments.
CO 6	Students will have an idea about truth functional compound proposition which is the base of symbolic logic.

### **Subject: 3. History – II**

#### **COURSE OBJECTIVES:**

Course attempts to acquaint the students about the impact of religious, Economic and Revenue Administration in Medieval India. The student is exposed to the effect of Islamic advent on Indian way of life. The students are exposed to understand rise of Marathas power and its administration under Shivaji. The course is designed to give fair idea about the Bhakti movement and Sufism. Course will give wider knowledge about judicial administration, procedures and crime and punishment in Medieval India

#### **COURSE OUTCOME:**

**Subject: 4. Family Law –II (Muslim Law)****COURSE OBJECTIVES:**

This Course on Muslim Law is designed to give to the students a basic knowledge and understanding about Islamic law. It will cover the basic outline about the different schools under Muslim Law. It will also talk about the traditional and modern sources of Muslim Law. Muslim Marriage is a civil contract however the students will be in a position to appreciate as how it is a sacrament as well. It will elaborate different traditional concepts like Muta Marriage, Dower, Option of Puberty etc. Through different provisions under law and case study students will understand the different rights available to Muslim women. This will also cover the Principles and competence to inherit the property under Muslim Law.

**COURSE OUTCOME:**

CO 1	The present syllabus dealing with the advent of Islam and development of Islamic law improve the students understanding of social evils prevailing in pre-Islamic Arabia which Islam wanted to address.
CO 2	Students are able to appreciate the circumstances which permitted the polygamous nature of Muslim marriage.
CO 3	That among the various personal laws of India, the Muslim Law was the first to provide for a divorce by mutual consent of the spouses.
CO 4	That under the Muslim personal law every women who inherits property is like a man, is its absolute owner.
CO 5	Given the private nature of Muslim marriage, the students are able to understand the need for the concept of “acknowledgement of paternity”

**Subject: 5. History – VI (Major Subject)****COURSE OBJECTIVES:**

This course attempts to enhance the knowledge of Students of International Affairs since 1945. This course also aims at the study of establishment, and role of United Nations Organisations as a Peace keeper. It also focuses on the knowledge of political issues persistent in different parts of world like Asia, Africa, Middle East countries and Indo –Pak Relations.

**COURSE OUTCOME:**

CO 1	Analyse the role of UNO in resolving political disputes in different countries.
CO 2	Elaborate the role of specialised agencies of United Nations Organisation
CO 3	Acquaint with the study of Cold War, its Origin and Evolution and its various phases and dimensions of Cold War and its effects on International Relations.
CO 4	Acquire the basic knowledge of Non alignment movement and the role of India in this movement.
CO 5	Evaluate the emergence of People’s Republic of china, Chinese Revolution under Mao Tse Tung and Chinese Foreign Policy under the Communist Regime.

**Subject: 6. Political Science – VI**

This course aims at studying the importance of international relations with special reference to foreign policies. It also focuses on the study of various aspects like expansion of International Community and Decolonisation and to upgrade the students with the history of Colonialism –Decolonialism.

### **COURSE OUTCOME:**

### **Subject: 7. Economics - VI**

#### **COURSE OBJECTIVES :**

1. To able to understand basic concepts of economics.
2. To able to analyze economic behavior in practice.
3. Understand the economic way of thinking.
4. The ability to analyze historical and current events from an economic perspective.
5. The ability to write clearly expressing an economic point of view.
6. Be exposed to alternative approaches to economic problems through exposure to coursework in Legal fields.
7. To create students ability to suggest of the various economic problems.

#### **COURSE OUTCOME:**

CO 1	able to understand international trade theories

### **Subject: 8. Philosophy – VI**

#### **COURSE OBJECTIVES:**

Applied ethics is a general field of study that includes all systematic efforts to understand and resolve moral problems that arise in the domain of practical life such as medical profession, legal profession, journalism and business. This paper tries to focus on the problem resolution in connection with some general issues and social concern such as employment, equity, capital punishment and euthanasia.

#### **COURSE OUTCOME:**

CO 1	Students will know about the Medical ethics, the facts of Medical profession, Doctors duty towards patients and general medical principles.
CO 2	Students will get knowledge about Professional ethics and business ethics.
CO 3	Students will understand the concept of Euthanasia.
CO 4	Students will understand the legal ethics and will be able to understand the duties of an advocate towards society, client, colleagues and opponent.

## **Subject: 9. Sociology – I**

### **COURSE OBJECTIVE:**

The first part of this course framed with the object to study the work of both early social theorists like Marx and Weber and more recent theorists like Louise, Garner, Tonnise and among others. The second part of this course will examine influential work on the major social institutions in India such as caste, tribe, religion, gender and class. Further, the scholarship surrounding secularism, communalism and nationalism in contemporary India will engage our attention. In addition to academic writings, we will sample sociologically relevant work from social activists and journalists.

### **COURSE OUTCOME:**

CO 1	The course enables the student to understand the meaning and variety of the definitions defined by the luminant Sociologist.
CO 2	The course provides the understanding regarding the relation between sociology with other social sciences viz. Economics, Political Science, Law and History.
CO 3	It provide the study on the concept of Status and Role it Coherence and Deviation in the society.
CO 4	It throws the light on the concept of the social group, its characteristic and classification of social group.
CO 5	The course will enable the students to study the concept of caste and class, its critical appraisal. It further provides the detail understanding on the concept of various institutions existed in the society.
CO 6	It laid the emphasis on the concept of social organisation and disorganization, It throws the light on Problems and Status of SCs, STs, BCs, and Minorities and the Legal Regime.; Problems and Status of Women, Children and the Legal Control, Problems of the Aged, Physically Challenged and its Legal Control.

## **B.A. LL.B. VII SEMESTER 5 YC**

### **Subject: 1. Labour Law –I**

#### **COURSE OBJECTIVES:**

This course develops students' knowledge and understanding of labour relations as well as essential labour laws governing terms and conditions of employment, with particular reference to India. The form and structure of legal regulation of employer employee relations is influenced by historical, economic and political factors. Student will be expected to gain an understanding of the various factors in the industrial relations system, the institutional relationships among the actors, and some of the norms and rules that are developed within the labour law system as well as through the jurisprudence evolved by the judiciary.

#### **COURSE OUTCOME:**

CO 1	Demonstrate an appreciation of the industrial, economic and social contexts in which labour is regulated.
CO 2	Demonstrate an understanding of the significance and content of the contract of employment and its relationship to industrial awards and

	workplace agreements.
CO 3	Demonstrate an understanding of anti-discrimination law and law regulating occupational health and safety.
CO 4	Describe the role of the Constitution in the federal system of industrial relations.
CO 5	Demonstrate an understanding of the operation of the conciliation and arbitration, the nature and significance of awards, the legal regulation of workplace agreements and the provision of minimum terms under industrial legislation.
CO 6	Demonstrate an understanding of the role of law in regulating industrial conflict;
CO 7	Demonstrate an understanding of the legal regulation of trade unions;
CO8	Demonstrate the skills required in applying legal rules and principles in the context of case laws and judicial evolution of labour laws and to demonstrate an intellectual capacity for solving industrial disputes..

## **Subject: 2. Human Right**

### **COURSE OBJECTIVE:**

The objective of this course is to make students aware of the principles of international humanitarian law and enable them to specialize in the field of Human Rights Law. The course helps in upgrading the knowledge of students with regard to Human rights of Disabled Persons, Indigenous persons, Persons with HIV – AIDS. It also focuses on the study of Child Rights Convention, Convention against Slavery, Convention on Refugees and other related international covenants enhancing the scope of Humanitarian Law.

### **COURSE OUTCOME:**

CO 1	The course will assist the students to understand the evolution of Human rights and how it is incorporated in various international conventions and domestic legislations.
CO 2	This course will help to acquaint the students with basic human rights institutions.
CO 3	The course will also be able to enhance the critical skills to equip the students with various aspects of Human rights violations.
CO 4	The students will be aware of the principles of international humanitarian law and enable them to specialize in the field of Human Rights Law.
CO 5	It will also assist students to take Project on working of relevant Human Rights Commission and study on incidence of Human Rights Violation.

### **Subject: 3. Transfer of Property**

#### **COURSE OBJECTIVES:**

The course framed with the object to know the concept of 'property' and the nature of property right are basic to the understanding of law relating to property. This course will study the concept in particular, its contemporary emphasis, on 'user', the evolution of the right to transfer property and the limitations operating thereon as laid down in the Transfer of Property Act. Necessary references will be made to the English law as well as to the doctrines of equity which have been responsible for the crystallization of the basic principles and doctrines of property law. The general principles and the provision on various modes (Lease, Mortgage, Sale, Gift and Exchange) relating to transfer of property will be studied.

#### **COURSE OUTCOME:**

CO 1	The course takes the students through the meaning and concept of property, historical background of transfer of property, various kinds of property with special reference to the subject matter of Transfer of property that is immovable property.
CO 2	The course enables the student to study the Transferable and non-transferable property.
CO 3	It provides the detail emphasis on the various doctrines regarding the conveyance of the immovable property.
CO 4	The course enables to study the various provisions on the different modes of the transfer of immovable property like sale, mortgage, lease, gift and exchange.
CO 5	With the various modes it enhance the understanding the rights and liabilities of the transferor and transferee under various modes of conveyance.

### **Subject: 4. Cyber Law**

#### **COURSE OBJECTIVES:**

The development of Information technology has developed the Communication. The course thus deals with all the aspects of Cyber law and deals with Indian IT act 2008. It covers the various aspects of Cyber crime. It also covers overview of Intellectual Property Right and Trademark Related laws with respect to Cyber Space. The course aims to give in depth knowledge of Information Technology Act and legal frame work of Right to Privacy, Data Security and Data Protection. It covers other cyber crimes that are taking place via the Internet.

#### **COURSE OUTCOME:**

CO 1	Students identify and analyse statutory and regulatory laws in the field of Information technology and apply diverse view point to recommend appropriate actions.
CO 2	Develop basis understanding about cryptology and key encryption techniques used.
CO 3	Provide an understanding of concepts relating to information security.
CO 4	Develop the knowledge of Information Technology Act.

CO 5	Give in-depth knowledge about the legal framework of cyber crime and cyber offences.
CO 6	To inculcate the significance of cyber Law, E - commerce, legal social and international issues and remedies available under IT Act.
CO 7	To enable the students to understand the digital signature.
CO 8	To explore overall legal IP issues and cyberspace.

### **Subject: 5. Public International Law**

#### **COURSE OBJECTIVE:**

The objectives of this course are to accustom students with fundamentals of Public International law and update them with the latest development. The study of this course helps students in exploring the various methods through which the State is recognised as well as modes through it may lose its existence. It also focuses on the study of relationship of individual with the State in international scenario. It also aims at enriching the students with new evolving aspects like Conventions such as Outer space Treaty, Moon Treaty and the Law of the Sea.

#### **COURSE OUTCOME:**

CO 1	This course will assist to acquaint the students with basics of Public International law and how it is related to Municipal law.
CO 2	It will be helpful to update them with the latest international treaties and conventions.
CO 3	It will make the students aware of various concepts like Extradition, Asylum and other related terms which will enable them to co relate with recent incidences.
CO 4	It enables students of international laws to specialize in the subject by having a detailed study of the purpose and functioning of different international organizations and their agencies.
CO 5	It also aids in analyzing Contemporary Issues in different parts of world.

### **Subject: 6. Sociology – II**

#### **COURSE OBJECTIVE:**

This course designed to let the student study the sociology of law and legal institutions in India in order to examine how the existing legal structures function in a society structured by religion, caste, class and gender. Further, the relationship between law and social movements will be considered. A special interest of this course is to scrutinize law as a cultural phenomenon. The second module of this course will deal with the conceptual difficulties and Role of GOs and NGOs in rural and urban settings.



### **COURSE OUTCOME:**

CO 1	The course emphasis on the study of the specific society at different places, it provides the study of concept of human ecology which enables the student to relate how human are related with its environment.
CO 2	The course provides the understanding for the student to know the existence of different communities exist in the society, namely rural community, urban community and Tribal community with its characteristic, issues and problems.
CO 3	It throws the light on the various terms like Village, Municipalities and Corporations, Rural Poverty, Bonded Labour, Agricultural Labour, Rural Employment, Town and Country Planning, Environmental Issues, Role of local bodies in Law enforcement, Gram Nyalaya, Lok Adalats, Right to Information Act, Legal Literacy.
CO 4	The course laid down the study regarding the Role of GOs and NGOs in rural and urban settings.
CO 5	It enables the student to study Social Work as a Profession, Methods and Techniques of Social Case Work, Social Group Work, Community Development and Social Action, Law and Public Opinion, Law as an instrument of Social Change, Tribe and Caste in the traditional Order - Caste and Class in Contemporary India - The Backward Classes.

### **B.A. LL.B. VIII SEMESTER 5 YC**

#### **Subject: 1. Civil Procedure Code and Limitation Act**

### **COURSE OBJECTIVES:**

The main objective of the said subject is that to sets out the rules and standards that Courts should follow while adjudicating the civil law suits. It helps the parties to understand the ways and means by which their rights and liabilities can be enforced. The course study and analyze and explains the competent and jurisdiction of civil courts. It helps the students to learn the Stages, Kinds and requirement to interpret the rules while conducting Civil litigations in Courts and further helps to solve the legal problems related to the requirement of the case when the students steps out in practice. It further analyze the law relevant to initiating and responding the suit filed between the parties in court. It defines the area of remedies in civil litigations matters, and explains in precision manner regarding the draft, pleading and discovery of documents in proper court format.

### **COURSE OUTCOME:**

CO 1	The course on Code of Civil Procedure helps the students to learn and deal with the procedure law which lays down the ways and means by which the substantive law can be enforced.
CO 2	The provisions dealt in Code of Civil Procedure will help the students to differentiate substantive and procedural law and explain the inter-relationship between the two areas when the students steps out in practice.
CO 3	The subject consolidates all the procedure to be followed by the Civil Courts in Civil Litigations. The course study and analyze and explains the competent and jurisdiction of civil courts.
CO 4	It further helps the students to learn the stages, Kinds and requirement to interpret the rules while conducting Civil litigations in Courts and further

	helps to solve the legal problems related to the requirement of the case.
CO 5	It further analyzes the law relevant to initiating and responding to the suit filed between the parties in court. It defines the area of remedies in civil litigation matters, and explains in precision manner regarding the draft, pleading and discovery of documents in proper court format.

**Subject: 2.Criminal Procedure Code, Probation of Offenders Act and Juvenile Justice Act**

**COURSE OBJECTIVES:**

This course focuses on the procedural aspects of criminal justice system. The course is divided into criminal procedure code, probation of offenders Act and juvenile justice act. The course will help students not only with procedural aspects but also with case study. It is additionally helpful in forming nexus between criminal jurisprudence and constitutional perspective. Criminal procedure code also discusses the rights of accused and principal of natural justice which forms the basis of the whole procedural law.

**COURSE OUTCOME:**

CO 1	This course is meant to be an overview of the Code of Criminal Procedure, 1973 which helps the functioning of the criminal justice system.
CO 2	The course elaborately deals with procedure to be followed by the police, the courts and other stakeholders when a crime has been committed.
CO 3	The course includes Constitutional perspective, rights of arrested and accused persons and principle and importance of fair trial.
CO 4	Additionally the course gives special attention to the procedure to be followed for juveniles under Juvenile Justice Act, 2000 and Probation of Offenders under Probation of Offenders Act, 1958.
CO 5	The course will study and analyse complex issues arising out of the provisions of the code and apply same in practice.

**Subject: 3.Law of Evidence**

**COURSE OBJECTIVES:**

The Indian Evidence Act was intended to be the complete code of evidence for India. The ultimate aim of producing evidence is to facilitate the judge to arrive at a rational conclusion with respect to the matters disputed before him. For this, Indian Evidence Act has within its fold four fundamental principles best evidence, relevancy, admissibility and appreciation. This course of law of evidence is structured in a fashion so as to encourage the students to appreciate the underlying principles of law of evidence. The course serves dual purpose- one, to technically equip students to be able to read the legal text and second to apply the same in actual cases. The stress in this course will also be on examining the judicial precedents where these principles have been subject to judicial scrutiny and interpretation.

### **COURSE OUTCOME:**

CO 1	This course will give good understanding of the elementary principle of the law of Evidence as laid down in Indian Evidence Act, 1872.
CO 2	The course will discuss the various principles and doctrine as given under the act and as interpreted by the courts.
CO 3	The course aims at the developing the capabilities to understand and apply the general principles such as relevancy and admissibility, burden of proof, presumptions and questioning of person.
CO 4	The course also aims at critical study of doctrine and principle of Res Gestae, plea of alibi, dying declaration etc.

### **Subject: 4. Labour Law –II**

#### **COURSE OBJECTIVES:**

This course develops students' knowledge and understanding of Social Security and Social Insurance provided to workers as well as essential welfare legislations governing terms and conditions of social insurance and social security. The form and structure of legal regulation of employer-employee relations is influenced by historical, economic and political factors. Students will be expected to gain an understanding of the various factors in the social security system, the institutional relationships among the employers and employees, and some of the norms and rules that are developed within the labour law system as well as through the jurisprudence evolved by the judiciary.

#### **COURSE OUTCOMES:**

By the end of this course, students should be able:

CO 1	To understand the nature and scope of Social Security and Welfare Legislations
CO 2	To describe the rationale of providing social security to the labour in organizations
CO 3	To identify all aspects of Labour welfare Legislations practiced in India
CO4	To exhibit a comprehensive theoretical and practical understanding of Welfare legislations and Laws related to workers
CO5	To demonstrate an intellectual capacity for solving workmen disputes relating to Social Security and Social Insurance.

### **Subject: 5. Health Law**

#### **COURSE OBJECTIVES:**

This Course on Health Law is designed to give to the students a basic knowledge and understanding about the different health policies adopted and the different Issues and challenges faced by the present health policy in India. This course will cover the historical development and the reasons behind the necessity of interference of Legislation in the health sector. It will cover the challenges faced due to

complicated Doctor Patient relationship in the commercialised world. It will also focus on very crucial issues like, surrogacy, status of HIV AIDS Patients, Organ Transplantation, Female foeticide, abortion etc. The course will also cover the socio, legal and ethical issues raised due to development in technology like Genetic engineering and stem cell therapy.

**COURSE OUTCOME:**

CO 1	This will enable students to study and understand the doctor patient relationship, different concepts like professional misconduct and remedies for it under civil and criminal law.
CO 2	This will sensitize the students towards different crucial issues which arose in a complex society like reproductive health, HIV-AIDS, Female foeticide, Surrogacy etc.
CO 3	This will also introduce the different advancement in medical science like Genetic Engineering and Stem Cell Therapy. Also the Socio, Legal and Ethical issues surrounding this. This will help students to critically evaluate these issues.
CO 4	Students will be able to understand the different legislations governing different issues of health and also the case laws. This will help them to apply the law and advice or provide for legal remedy to the real life cases.
CO 5	Will be able to understand the different challenges faced by health care sector in India and will be in a position to participate in or suggest reforms in developing regulations in the health care industry.
CO 6	Will understand the professional and ethical obligations of different participants and professionals in the healthcare industry.

**Subject: 6. Law of Trust (Optional Paper)**

**COURSE OBJECTIVE:**

This course designed to provide the understanding with the nature and historical evolution of Trusts, different types of Trust, the concept of the creation of the trust and their right, duties and powers, liabilities of both trustee and that of beneficiary. The second module of the course framed with the intent to study the registration of the public trust and the important doctrines with the relevant cases decided by the courts.

**COURSE OUTCOME:**

CO 1	The course enhances the cognitive domain of the student to understand the term of trust and the different terminologies used in trust. It further states the development of trust law and equity, the meaning and nature of trust.
CO 2	It provides the understanding on the creation of the trust, various rights, duties and liability of the trustee.
CO 3	It further gives the details of various rights, duties and liability of the beneficiary.
CO 4	The course states the occasion where the trust extinguishes.

## **Subject: 7. Insurance Law**

### **COURSE OBJECTIVES:**

Insurance is a very technical subject. So, while dealing in insurance matters, finance professional or an investor should understand the basic concepts and principles of insurance. This subject course thus designed to enable the students to understand the need of studying principles of insurance. It covers meaning of insurable interest in insurance agreements and its importance, meaning of indemnity and its importance in insurance claims, Meaning of 'Uberrimae fidei' and its use in Insurance contracts. Study focuses on various laws and regulations related to general insurance business in India.

### **COURSE OUTCOME:**

CO 1	Acquire specialized knowledge of law and practice relating to Insurance
CO 2	Study the principles and practice of general insurance claims.
CO 3	Understand the legal procedures to be followed for processing a claim.
CO 4	Study the importance of evaluating and assessing genuine claims.
CO 5	To know the concept of Marine insurance and its types.
CO 6	Understand the features of different types of Liability insurance.
CO 7	Understand the essentials of a valid insurance contract.
CO 8	Analyze the meaning and significance of the principle of Life insurance.

## **B.A. LL.B. IX SEMESTER 5 YC**

### **Subject: 1. Land Laws**

### **COURSE OBJECTIVES:**

The object of this paper is to focus on land reforms besides land acquisition procedures enunciated in the Act. Each state has the power to make special laws or rules with respect to the land under its jurisdiction with respect to transfer of agricultural property, which includes registration or prohibiting persons from alienation or transfer of it. Land Law addresses the legal mandates set forth by a country in regards to land ownership. It provides in-depth knowledge on Central and State Land Laws. The course focuses on enhancing the skills, interpretation and application of different types of Land Laws. To focus on land reforms besides Land Acquisition procedures enunciated in the Act of 1894 & 2013 and the constitutional perspective relating to this subject have to be taught as an essential part of this course.

### **COURSE OUTCOME:**

CO 1	The present subject Land Laws incorporates basic land laws that are Maharashtra Land Revenue Code 1966, The Maharashtra Regional and Town Planning Act, 1966 and Land Acquisition Act, 1894. The Land Acquisition Act gives the procedure for acquisition and compensation with reference to same. Along with said laws the study also includes details regarding Classification of lands.
------	--

CO 2	The said subject makes the students aware about the law to acquire land of others. It makes students understand that the power of government to acquire land is not absolute.
CO 3	The course will study and analyze about the rule regarding compensation for acquisition of land
CO 4	The study of the present subject makes the student aware about the laws regarding Land and Land revenue which are in force in different parts of state of Maharashtra.
CO 5	The study helps the students aware about the constitution of Regional Town Planning Board, its duties and powers.
CO 6	The study not only makes student understand the procedure for preparing and sanctioning the development plan but also the effects of unauthorized developments.

## **Subject: 2. Interpretation of Statute**

### **COURSE OBJECTIVES:**

The Course is designed in such a way so as to impart knowledge about the Principles of Interpretation, Rules of Interpretation, External aids to Interpretation. The Course creates a foundation for the law students by introducing them with the nuances of Interpretation of Statutes which will further help them in developing Legal acumen.

### **COURSE OUTCOME:**

CO 1	Understand various Rules of Interpretation, Principles of Interpretation etc.
CO 2	Develop their ability to Interpret Penal Statutes, Statutes of Taxation etc.
CO 3	Apply their mind to the reasoning of any Judicial decision which will act as a catalyst in the process of development of Legal insight and expertise.

## **Subject: 3. Intellectual Property Law**

### **COURSE OBJECTIVE:**

The course has been designed to study the novel avenue of the typical kind of intangible property in the name of Intellectual property. This course aims to study the existing (copyright, patent, trademark and designs) and emerging (computer software) forms of intellectual property in terms of Indian law and policy as well as new international demands and trends. Besides, the course will examine the philosophical foundations of recognizing intellectual property rights, its relation with public interest and socio-economic development and the demands of equity and compulsions of international trade.

### **COURSE OUTCOME:**

CO 1	The course enhances the cognitive domain of the student regarding the meaning of Intellectual property and its nature and types.
CO 2	The course divides the study of the student to go through the respective IP

	laws enacted for separate IP by the legislature.
CO 3	It provides the knowledge regarding the different subject matter falling under the respective field of intellectual property.
CO 4	The course emphasis on the term of protection to different IP laws, the right of IP holder, Process of the registration.
CO 5	It also provides the various instances of the infringement of Intellectual property.
CO 6	In order to enable the practical knowledge to the student, it provides the plethora of the famous and landmark case with respect to all Intellectual property laws.

#### **Subject: 4. Alternative Dispute Resolution (Clinical Paper –I )**

##### **COURSE OBJECTIVES:**

The course aims at providing an overview of how Alternative Dispute Resolution has become the primary means by which cases are resolved now days, especially commercial, business disputes. It has emerged as the preferred method for resolving civil cases, with litigation as a last resort. The course also focuses on an introduction to Arbitration and conciliation proceedings apart from the traditional negotiation and mediation theory.

CO 1	This clinical course will assist the students in demonstrating the various skills and techniques of Alternative Dispute Resolution especially in commercial, business disputes.
CO 2	Alternative Dispute Resolution will aid the students in application of the statutory provisions of the relevant Act and use case law emphasizing these processes during litigation.
CO 3	This course will make the students skilled not only in litigation but also in problem-solving through negotiation and mediation, which costs the clients less in terms of time and money.
CO 4	Through this course the students will be well versed in conducting the proceedings of LokAdalats, Family Courts and Tribunals.
CO 5	The students will also be able to reflect the arbitration proceedings in their practice as an alternative to traditional court practice.

#### **Subject: 5. Professional Ethics and Professional accounting System (Clinical Paper –II)**

##### **COURSE OBJECTIVES:**

Every profession has certain peculiar codes of conduct and well defined norms. Ethics are an integral part of every profession. Advocacy being a profession of immense social relevance, and its significant role in the justice delivery system makes it a unique profession in itself and therefore it is highly desired that this profession be carried on ethically. This course aims at appreciating the role of advocates as well as the Bar-Bench relation. Designed to be taught with the assistance of practitioners, it will impart the students their role and responsibilities as professionals.

**COURSE OUTCOME:**

CO 1	To understand the contempt law in India and the classifications of contempt, the punishments and remedies etc.
CO 2	It involves practical training and involves case studies by the students and case presentations in the class.
CO 3	Acquaint the students with general principles of accounting.
CO 4	The students will be able to understand the historical evolution of the legal profession as well as the various codes of conduct and ethical norms for the advocates.
CO 5	Introduce the professional accountability concept to budding lawyers.
CO 6	Impart an idea on the professional accounting system for lawyer.

**Subject: 6. Criminology and Penology (Optional Paper – I)****COURSE OBJECTIVES:**

The Course is designed with an objective to acquaint the students with different Theories of Criminology, factors responsible for criminal behaviour so as to develop their analytical ability. It also focuses on the core areas of Criminal Justice system including the treatment for correction of offenders which would act as a precursor in developing research interest in the students at later stage.

**COURSE OUTCOME:**

CO 1	Demonstrate adeptness in the understanding of various Theories of Criminology and factors responsible for criminal behaviour, Penal policy, Correctional strategies, victimology etc.
CO 2	Think out of the box and assess and evaluate independently the Criminal Justice System in India.
CO 3	Articulate original thoughts about the formation of strategies for re-socialisation of offenders.
CO 4	Pursue higher research in the field of Criminology and Penology at later stage after creating a strong foundation through this subject.

**Subject: 7 Right To Information (Optional Paper – I)****COURSE OBJECTIVES:**

The course aims at emphasising the importance of Fundamental Right to Information in democracy. It also focuses on the study of necessity of having a comprehensive enactment on right to information. It enhances the knowledge of students with regard to role of Public Information Officer and their Duties and Onus on the PIOs. It also emphasises on the role of Civil Society Organizations and Media for Good Governance.



### **COURSE OUTCOME:**

CO 1	This course will be helpful in acquiring comprehensive knowledge of the provisions of the RTI Act, 2005 and its general applicability in day to day affairs while dealing with governmental agencies.
CO 2	It will make the students analyse the roles and responsibilities of government officers concerned while implementing the law and enforcing the rights of the citizens.
CO 3	Through this course the students will be able to evaluate the remedies available to a citizen whose right is infringed due to non-compliance of the said Act.
CO 4	The students will also study decisions rendered by State Information Commissions and Central Information Commission relating to different Government Departments.
CO 5	The students will be able to demonstrate the role of Civil Society Organizations and Media for Good Governance.
CO 6	It will be able to express the importance of records management for Effective Information through Best practices.

### **B.A. LL.B. X SEMESTER 5 YC**

#### **Subject: 1. Administrative Law**

#### **COURSE OBJECTIVES:**

The course enriches the students with the basic Principles of Administrative Law including quasi-legislative, quasi-judicial and other ministerial functions of administration and control thereof with a practical approach. This course also aims at studying the notions like Administrative Discretion and Delegated legislation, where it reflects the due diligence on the part of administrative authorities while taking any action.

#### **COURSE OUTCOME:**

CO 1	The course will make students receptive of various aspects of Administrative Law including quasi-legislative, quasi-judicial and pure ministerial functions of administration and appreciate how judiciary controls the various administrative authorities through judicial review.
CO 2	It will assist students in examining the tortious and contractual liabilities of the State for seeking relief from government, its agencies and instrumentalities through different kinds of writs.
CO 3	It will enable to explore the various concepts like Rule of law, Theory of Separation of powers, and its applicability in modern day.
CO 4	This course will be helpful in examining the notions like Administrative Discretion and Delegated legislation and analysing its control mechanisms.

CO 5	It gives students insight into principles of administrative law like Natural justice, promissory estoppel, legitimate expectation, and doctrine of proportionality.
CO 6	Through this course the students will be able to demonstrate the scope and functions of various Parliamentary committees, Commissions of Inquiry, Administrative Tribunals and Central Vigilance Commission.

## **Subject: 2. Banking Law**

### **COURSE OBJECTIVE:**

The banking industry in India is one of the advanced sections of Indian economy. The legal framework even after nationalization has provided so much scope for competitive development that it deserves to be studied in context in the law curriculum. This course aims to study banking law and practice in the perspective of the changing trade and investment scenario of the country with special reference to Securitization Act, 2002 and Law relating to Negotiable Instruments, 1881 Act.

### **COURSE OUTCOME:**

CO 1	The course takes through the student the concept of Indian banking system, origin and evolution of banking.
CO 2	It provides the study of Employment of funds, Loans and Advances, Guarantees, Financing of Exports, Special Banking Services, Advances to Priority Sectors and Credit Guarantee schemes with special reference to Securitization Act, 2002.
CO 3	The course enables the student to study the Law relating to Negotiable Instruments, 1881 Act.
CO 4	It provides the emphasis on the banker customer relationship with specific provision on the banker's duty.
CO 5	The course enhances the understanding of the student with regard to Special types of customers.
CO 6	It further throws the knowledge with respect to ancillary services and e-banking with the importance of banking ombudsman.

## **Subject: 3. Law of Taxation**

### **COURSE OBJECTIVE:**

Direct taxes and its administration is the main focus of this course. The principles of taxation (income tax, corporation tax, wealth tax), the system of tax assessment, recovery and administration, the incidence of tax in production, consumption saving and income distribution are discussed in the course with the help of case law and statutory provisions. A major concern in the course is to relate the economic policies and processes to tax and fiscal policies in different systems of economic administration keeping the constitutional goals in view.

### **COURSE OUTCOME:**

CO 1	The course enhances the cognitive domain of the student regarding the Constitutional basis of power of taxation
CO 2	The course divides the study of the student to go through the provisions on Incomes which do not form part of Total Income; Heads of Income and

	Computation Income from Salary, Income from House Property- Profits and Gains of Business or Profession Capital Gains and Income from other sources.
CO 3	It provides the knowledge regarding the Law and Procedure for Assessment, Kinds of Assessment, Penalties, Prosecution, Appeals and Grievances Authorities.
CO 4	It also provides the Relevant important provisions of Maharashtra Value Added Tax Act 2002, its Assessment Procedure and Practice of Sales Tax and VAT , the important Authorities and their Powers and Jurisdiction.
CO 5	It enables the student to study how to file the Returns, Statement of net wealth, Computation of Wealth Tax, Valuation rules for immovable property, Business Assets, Jewelry.

### **Subject: 4. Drafting , Pleading and conveyancing ( Clinical paper III)**

#### **COURSE OBJECTIVES:**

This Paper aims at giving the students an opportunity to understand and refer to various practical aspects of civil and criminal laws. It also emphasizes on the conveyancing aspects and imparts the students the requisites of various deeds that go to make the theoretical law complete.

#### **COURSE OUTCOME:**

CO 1	Understand the general principal of drafting and substantive rules.
CO 2	Know the principles of conveyancing with reference to different deeds.
CO 3	The students will be in a position to understand the basic rules of judgment writing.
CO 4	Will be able to write civil plaint as well as other civil and criminal pleadings.
CO 5	Will be able to draft deeds.
CO 6	Will be able to deal civil as well as criminal matters.

### **Subject: 5. Moot Court and Internship (Clinical paper III)**

#### **COURSE OBJECTIVES:**

This course is designed to introduce the students to the practical aspects of the profession by organizing moot courts and sending them to courts for a personal experience of the functioning of courts. In this connection it to provide the necessary feels of the court room environment to the students by arranging moot courts. It aims at taking the students to Courts visits, periodically, to observe and note down the different stages of judicial proceedings. It aims at providing an opportunity to the students to visit the Lawyers' Chambers regularly and acquaint themselves with the techniques of client interviewing. The Viva Voce is taken by external examiner to evaluate the student.

**COURSE OUTCOME:**

CO 1	The student will be able to appreciate the research and argument skill required by the Lawyer.
CO2	Get the practical exposure about the techniques of client interviewing.
CO 3	Will understand the preparation of court papers and documents
CO 4	Will know the procedural steps involved in the preparation of brief by an Advocate.
CO 5	Will understand the process of filing suit or petition.
CO 6	Help the student to improve analytical skill.

**Subject: 6. INTERNATIONAL TRADE LAW (OPTIONAL PAPER I)****COURSE OBJECTIVES:**

This introductory course deals with structural aspects of the international trade law system, the history of the international legal system; customary international law; treaty law and interpretation; the meaning and jurisprudence of international law statehood and recognition; international organizations such as the United Nations, the World Trade Organization, the IMF, World Bank, UNCTAD, UNCITRAL and ICSID as well as the relationship between the international legal system and domestic systems. The course will provide a study of the modes of International Trade Contracts ;INCO Terms affecting the International Trade and contracts; In addition the course will review the legal vehicles available to facilitate international dispute resolution methods for governments and business entities.

**COURSE OUTCOME:**

CO 1	The overall aim of the course is to enable students to critically examine the legal operation of international trade agreements and their application and impact on international business and trading activities.
CO 2	To understand the key international agreements covered under the GATT/WTO multilateral trading framework.
CO 3	To understand the nature of international trade law within the structure of the international legal system.
CO 4	To consider the roles played by international organisations including the United Nations, the World Trade Organisation, UNCTAD, UNCITRAL and ICSID.
CO 5	To examine legal mechanisms available to facilitate international dispute resolution for governments and business, and the recognition of foreign awards and judgments.

## **Subject: 7. Women and Law (Optional Paper II)**

### **COURSE OBJECTIVES:**

The course on women and law walks the students through specific laws that deal with the provision of security, protection and protective discrimination of women. The course is divided to include the laws that provide physical, personal and mental protection to women who are discriminated against and the women who are marginalised in the society. The course will Study and analyze, what are the legal provisions enacted to ameliorate these situations with special emphasis on Indian Municipal Law and what is the scope and shortcomings in the existing legal regime in this regard.

### **COURSE OUTCOME:**

CO 1	Students graduating with Women and Law will be able to: Apply a systematic approach to eliminate on the ideas in the institutions which marginalize, subordinate and accord secondary citizenship to women and underestimate or makes the women's contribution invisible.
CO2	Analyse the laws that specifically govern the protection of women and accord them social security.
CO 3	Identify and discuss issues related to women and girl child at rural and urban areas vis a vis the protection mechanism provided by laws and the judicial system.
CO 4	Understand the new legislations that provide protection to women at the domestic level as well as at workplaces.
CO 5	Analyse the efficacy of laws that prevent discrimination of women.
